## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This Release of Security Interests in Trademarks ("Release"), dated as of May 10, 2018, is made by Cortland Capital Market Services LLC, as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Agent"). Reference is hereby made to that certain Pledge and Security Agreement, dated April 28, 2011 (as amended, restated, supplemented, modified or otherwise changed from time to time, and including any grants of security interest made pursuant thereto, the "Security Agreement"), by and between Licensing IP International S.à r.l. (f/k/a Manwin Licensing International S.à r.l.) ("Licensing," and collectively, with the Borrowers, Guarantors, and the parties listed below granting security interests in favor of the Agent, "Grantor"), Agent, and the other parties thereto. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

**WHEREAS**, pursuant to the Security Agreement, Grantor executed and delivered to the Agent:

- (i) that certain Grant of a Security Interest – Trademarks, dated as of April 28, 2011, by Licensing, in favor of Agent, recorded in the United States Patent and Trademark Office ("USPTO") April 29, 2011, at Reel/ Frame 4531/0675,
- (ii) that certain Grant of a Security Interest – Trademarks, dated as of June 1, 2011, by Licensing in favor of Agent, recorded in USPTO June 2, 2011 at Reel/ Frame 4553/0184,
- (iii) that certain Grant of a Security Interest – Trademarks, dated as of October 31, 2011, by Licensing in favor of Agent,
- (iv) that certain Grant of a Security Interest – Trademarks, dated as of March 1, 2012, by Licensing in favor of Agent, recorded in USPTO March 2, 2012 at Reel/ Frame 4728/0630,
- (v) that certain Grant of a Security Interest – Trademarks, dated as of September 10, 2012, by MG IP S.à r.l. (f/k/a Manwin IP S.à r.l.) in favor of Agent,
- (vi) that certain Grant of a Security Interest – Trademarks, dated as of November 22, 2013, by Licensing in favor of Agent, recorded in USPTO November 27, 2013 at Reel/ Frame 5163/0116,
- (vii) that certain Grant of a Security Interest - Trademarks, dated as of December 30, 2013, by Midstream Media International, N.V. in favor of Agent, recorded in USPTO December 31, 2013 at Reel/ Frame 5184/0478, and
- (viii) that certain undated Grant of a Security Interest – Trademarks, by Licensing in favor of Agent,

(collectively, the "Trademark Security Grants"), and

**WHEREAS**, the Agent desires to release any and all security interest it has in any of the following (collectively, the "Released Collateral"): (i) any Collateral consisting of Trademarks, (ii) the Trademarks set forth in the Trademark Security Grants, and (iii) the Trademarks set forth on Schedule I attached hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) reconveys, releases, terminates, and forever discharges any and all security interests and other rights that were pledged, assigned, or granted to it in the Released Collateral, and (ii) transfers and assigns to Grantor any right, title, or interest the Agent may have in, to, or under the Released Collateral. The Agent hereby agrees to take such further




