The parties understand and intend that this Trademark and Domain Name Assignment is to be recorded in the United States Patent and Trademark Office and elsewhere around the world as appropriate.


Assignor agrees to execute all instruments and documents and do such additional acts as Assignee may deem necessary or desirable to effect, evidence, record, and perfect the assignment and recordation of the rights being assigned hereunder. If Assignee is unable for any reason whatsoever to secure Assignor's signature to any document it is entitled to under this Trademark and Domain Name Assignment, Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents, as its attorneys-in-fact, with full power of substitution to act for and on their behalf and instead of Assignor to execute and file any such document or documents and to do all other lawfully permitted acts to further the purposes of the foregoing with the same legal force and effect as if executed by Assignor.

This Trademark and Domain Name Assignment will inure to the benefit of and be binding upon Assignee and Assignor and their respective heirs, successors, and assigns.

This Trademark and Domain Name Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. 
