TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS, dated as of August 1, 2018 (this “**Termination and Release**”), by Wilmington Trust Company (“**WTC**”), as Second Priority Collateral Trustee (as defined below) in favor of Name Rite, L.L.C. (the “**Grantor**”). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Second Priority Subsidiary Security Agreement, referred to below.

Reference is made to the Second Priority Subsidiary Security Agreement dated as of June 27, 2001, as amended and restated as of May 28, 2003 (as further amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the “**Second Priority Subsidiary Security Agreement**”), among Subsidiary Guarantors from time to time party thereto and Wilmington Trust Company, as collateral trustee (in such capacity, the “**Second Priority Collateral Trustee**”).

WHEREAS, pursuant to the Second Priority Subsidiary Security Agreement, the Grantor granted to the Second Priority Collateral Trustee, for the benefit of the Second Priority Debt Parties, a security interest in all right, title or interest of the Grantor in certain intellectual property, including, among other things, the trademarks and trademark applications of the Grantor set forth on Schedule I hereto (collectively, the “**Trademarks**”), which security interests were recorded with the United States Patent & Trademark Office on (a) August 9, 2001 at reel/frame 2341/0031, (b) August 9, 2001 reel/frame 2341/0357, (c) August 9, 2001 reel/frame 2346/0397, and (d) July 17, 2003 reel/frame 2772/0556;

WHEREAS, pursuant to the Second Lien Payoff Letter dated as of January 24, 2018, the Second Priority Collateral Trustee agreed to release all right, title and interest granted to it, for the benefit of the Second Priority Debt Parties, under the Second Priority Subsidiary Security Agreement in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Second Priority Collateral Trustee hereby (a) terminates, cancels and releases any and all security interests it has in and against the Trademarks and (b) reassigns all right, title and interest it may have in, to or under the Trademarks, together with the goodwill associated therewith, including without limitation any renewals of any of the foregoing, and any proceeds of the foregoing, and any claims against third parties for past, present or future infringement or dilution of the Trademarks, to the applicable Grantor.

At the Subsidiary Guarantor’s sole cost and expense, the Second Priority Collateral Trustee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.


THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE SECOND PRIORITY

COLLATERAL TRUSTEE'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
