

Capitalized terms used herein, unless otherwise defined herein, shall have the meanings ascribed to such terms in the Trademark Notice.

This Release of Security Interest in Trademarks (this "Release") is intended to operate as a release of all liens and security interests conveyed by Grantor to Agent pursuant to the terms of the Trademark Notice, and to reassign to Grantor all of Agent's right, title, and interest acquired pursuant to the terms of such Trademark Notice.
