TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (“Assignment”) is made and entered into as of June 21, 2018 (the “Effective Date”), by and among Robert Sonneman (“Sonneman”), Sonneman LLC (“LLC”), and Sonneman Design Group, Inc. (“SDG” and, together with each of Sonneman and the LLC, each, an “Assignor” and together, the “Assignors”), on the one hand, and Contemporary Visions, LLC (“Assignee”), on the other hand.

WHEREAS, Assignor owns the trademarks and trademark applications set forth on Schedule A attached hereto (the “Trademarks”);

WHEREAS, Assignors, Assignee and the other parties thereto are parties to the Intellectual Property Assignment Agreement dated June 21, 2018 (the “IP Assignment Agreement”) pursuant to which Assignors have sold, and Assignee has purchased, certain assets of Assignors, including, without limitation, the Trademarks; and

WHEREAS, pursuant to the IP Assignment Agreement, each Assignor wishes to assign to Assignee, and Assignee wishes to acquire from each Assignor, all worldwide right, title and interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, each Assignor hereby agrees:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Assignor hereby grants, conveys and assigns, and will cause its affiliates to assign, to Assignee, on a worldwide basis, all of its right, title and interest in and to the Trademarks listed on Schedule A hereto, including those that are registered and those that are pending registration, together with the associated goodwill in the Trademarks and in the business, products, and services symbolized by the Trademarks, including any and all rights, priorities, and privileges of each Assignor under the laws of the United States and any of its states, the laws of any other jurisdiction, multinational law, and any compact, treaty, protocol, convention, or organization, subject to such currently outstanding license or use rights to the Trademarks as currently exist, if any. Each Assignor and Assignee hereby authorizes the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities, to record Assignee as the assignee of all of each Assignor’s right, title and interest in, to and under the Trademarks and to deliver to Assignee, and to Assignee's attorneys, agents, successors or assigns, all official documents and communications.

2. Governance. Notwithstanding any other provision of this Assignment to the contrary, nothing contained in this Assignment shall in any way supersede, merge with, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect the provisions set forth in the IP Assignment Agreement nor shall this Assignment reduce, expand or enlarge any remedies under the IP Assignment Agreement. This Assignment is intended only to effect the assignment of the Trademarks pursuant to the IP Assignment Agreement and shall be governed entirely in accordance with the terms and conditions of the IP Assignment Agreement.

3. Disclaimer. ASSIGNORS AND ASSIGNEE ACKNOWLEDGE AND AGREE THAT THE TRADEMARKS BEING ASSIGNED, TRANSFERRED OR CONVEYED PURSUANT TO SECTION 1 ARE BEING ASSIGNED, TRANSFERRED AND CONVEYED TO THE ASSIGNEE ON AN “AS IS” AND “AS AVAILABLE” BASIS WITHOUT ANY LIABILITY OR INDEMNIFICATION BY ASSIGNORS TO ASSIGNEE AND WITH NO GUARANTEE, REPRESENTATION OR

WARRANTY OF ANY KIND, WHETHER EXPRESS OR IMPLIED (ORAL OR WRITTEN), INCLUDING AS TO THE IMPLIED WARRANTIES OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, SATISFACTORY QUALITY, QUIET ENJOYMENT OR ARISING FROM A COURSE OF DEALING OR USAGE OF TRADE, AND ASSIGNEE HEREBY EXPRESSLY DISCLAIMS (ON BEHALF OF ITSELF AND ITS AFFILIATES) ALL SUCH GUARANTEES, REPRESENTATIONS AND WARRANTIES HEREUNDER; PROVIDED, HOWEVER, THAT NOTWITHSTANDING ANYTHING TO THE CONTRARY CONTAINED HEREIN, THIS SECTION 3 SHALL NOT MODIFY, LIMIT, OR OTHERWISE AFFECT OR RELIEVE THE PARTIES OF THEIR RESPECTIVE REPRESENTATIONS, WARRANTIES, COVENANTS, OBLIGATIONS, OR AGREEMENTS CONTAINED IN THE PURCHASE AGREEMENT OR THEIR RESPECTIVE COVENANTS, OBLIGATIONS, OR AGREEMENTS CONTAINED IN THE IP ASSIGNMENT AGREEMENT, OR MODIFY, LIMIT, OR OTHERWISE AFFECT OR RELIEVE THE PARTIES OF THEIR RESPECTIVE COVENANTS, OBLIGATIONS, OR AGREEMENTS CONTAINED IN ANY OF SECTIONS 2, 4, 5, 6, or 7.

4. Counterparts. This Assignment may be executed in one or more counterparts, any one of which need not contain the signatures of more than one person, but all such counterparts taken together will constitute one and the same instrument.

5. Successors. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, legal representatives, successors and assigns.

6. Further Assurances. Each Assignor shall take all further actions, and provide Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation), as reasonably requested by Assignee to more fully and effectively evidence or effectuate the purposes of this Assignment, including, without limitation, executing any forms of assignment substantially similar hereto as necessary for filing in any jurisdiction outside of the United States.

7. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York, regardless of the laws that might otherwise govern under applicable principles of conflicts of laws thereof.




