## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of July 2, 2018 (the “Effective Date”), is made by Jefferies Finance LLC, in its capacity as Second Lien Administrative Agent (the “Agent”), in favor of Reddy Ice Corporation, a Nevada corporation (the “Grantor”).

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of May 1, 2013, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Second Lien Administrative Agent, a security interest in and to and a continuing lien on certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered (i) a Trademark Security Agreement (the “Original Trademark Security Agreement”), dated as of May 1, 2013 and recorded with the United States Patent and Trademark Office on May 2, 2013 at Reel/Frame 5019/0576 and (ii) a Supplemental Trademark Security Agreement (the “Supplemental Trademark Security Agreement”, and together Original Trademark Security Agreement, the “Trademark Security Agreements”), dated as of August 24, 2015 and recorded with the United States Patent and Trademark Office on August 27, 2015 at Reel/Frame 5610/0162;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.
2. Release. The Agent, without recourse, representation or warranty of any kind, hereby releases, discharges, terminates, and cancels all of its security interest in and to and under the Trademark registrations and applications of Pledgor, including those set forth on Schedule I hereto (the “Released Trademarks”), all Goodwill associated with such Trademarks; and all Proceeds of any and all of the foregoing (other than Excluded Property) (collectively “Released Collateral”). If and to the extent that the Agent has acquired any right, title or interest in and to the Released Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
