GRANT OF SECURITY INTEREST IN UNITED STATES AND CANADIAN TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, ROCKPORT IP HOLDINGS, LLC, a Delaware limited liability company ("Rockport IP" and the "Grantor"), hereby grants to GORDON BROTHERS FINANCE COMPANY, in its capacity as administrative and collateral agent for the Secured Parties (as such term is defined in the Term Loan Credit and Guaranty Agreement dated as of August 2, 2018, as amended, modified, restated and/or supplemented from time to time, the "TL Credit Agreement") (in such capacity, the "Grantee"), a continuing security interest in (a) all of the Grantor's right, title and interest in, to and under any and all Trademarks (as such term is defined in the U.S. TL Security Agreement described below), including, without limitation, the trademark registrations and trademark applications and recordings set forth on Schedule A attached hereto (the "Marks"), (b) all rights and privileges arising under applicable law with respect to the Marks, (c) the goodwill of the business symbolized by each of the Marks, (d) all income, fees, royalties and other payments now or hereafter due or payable with respect thereto, including, without limitation, payments under all licenses at any time entered into in connection therewith; (e) the right to sue for past, present and future infringements or any other violations of the Marks, (f) all rights corresponding thereto, (g) all causes of action arising prior to or after the date hereof relating to our arising from the same, (h) all present and future license agreements pertaining to the Marks, and (i) any and all other proceeds of any of the foregoing.

The Grantor authorizes and requests that the Commissioner of Patents and Trademarks and the Canadian Intellectual Property Office record this Grant against the Marks.

THIS GRANT (the "Grant") is made to secure the satisfactory performance and payment of all the Obligations of the Grantor, as such term is defined in the U.S. Term Loan Pledge and Security Agreement, dated as of August 2, 2018 (as amended, modified, restated and/or supplemented from time to time, the "U.S. TL Security Agreement"; capitalized terms used but not otherwise defined herein shall have the meanings assigned to such terms in the U.S. TL Security Agreement), (i) CB MARATHON MIDCO, LLC, a Delaware limited liability company ("Holdings"), (ii) CB MARATHON OPCO, LLC, a Delaware limited liability company ("Rockport U.S."), and (iii) certain other direct and indirect Subsidiaries of Holdings that are party thereto from time as grantors (collectively and jointly and severally, in such capacities and together with any successors in such capacities, the "Grantors" and each, a "Grantor"), as pledgors, assignors and debtors, in favor of GORDON BROTHERS FINANCE COMPANY, in its capacity as administrative agent and collateral agent for the Secured Parties (as defined in the TL Credit Agreement) pursuant to the TL Credit Agreement, as pledgee, assignee and secured party (in its capacities as collateral agent and administrative agent and together with any successors in such capacities, the "TL Agent").

The Grantor does hereby acknowledge and confirm that the grant of the security interest herein, and the rights and remedies of the Grantee with respect to the security interest granted herein, are more fully set forth in the U.S. TL Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the U.S. TL Security Agreement, the provisions of the U.S. TL Security Agreement shall govern.

THIS GRANT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY OTHER LAW.
