NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of August 1, 2018 is made by CITIBANK, N.A., in its capacity as collateral agent (in such capacity, the “Collateral Agent”), in favor of WESTINGHOUSE ELECTRIC COMPANY LLC, a Delaware limited liability company (the “Pledgor”).

W I T N E S S E T H:

WHEREAS, in connection with that certain Guarantee and Collateral Agreement (DIP Term Loan Facility), dated as of May 26, 2017, among the Collateral Agent, the Pledgor and the other parties thereto (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Pledgor executed and delivered that certain Trademark Security Agreement, dated as of May 26, 2017, in favor of the Collateral Agent (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, the Pledgor assigned and pledged to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in all of such Pledgor’s right, title and interest in, to and under the IP Collateral, including all trademarks, service marks, corporate names, company names, business names, trade dress, logos and taglines, all registrations thereof (if any), and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States of America, and all renewals thereof, including the trademarks set forth on Schedule A attached hereto, together with all goodwill associated with or symbolized by such trademarks (collectively, the “Released Trademarks”);

WHEREAS, the Collateral Agent recorded its security interest in the Released Trademarks with the United States Patent and Trademark Office (the “USPTO”) on May 31, 2017, at Reel/Frame No.006073/0021; and

WHEREAS, the Collateral Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent agrees, for the benefit of the Pledgor, as follows:

1. Definitions. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement or the Security Agreement, as applicable.

2. Release of Security Interest. The Collateral Agent does hereby release, relinquish and discharge its lien on and security interest in all of the Pledgor’s right, title and interest in, to and under the Released Trademarks.

3. Termination. The Collateral Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.


4. Further Assurances. The Collateral Agent hereby authorizes the Pledgor or the Pledgor's authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Collateral Agent in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Collateral Agent further agrees to execute and deliver to the Pledgor any and all further documents and instruments, and do any and all further acts which the Pledgor (or its agents or designees) reasonably requests in order to confirm this Release and the Pledgor's right, title and interest in, to and under the Released Trademarks.

5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
