## **RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of July 2, 2018, by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Collateral Agent (the “Collateral Agent”), in favor of VIEWPOINT, INC., a Delaware corporation (“Viewpoint”) and DEXTER & CHANEY, LLC, a Delaware limited liability company (together with Viewpoint, the Grantors”).

Reference is made to that certain (i) Payoff Letter (Second Lien Credit Agreement), dated as of the date hereof, by and among Credit Suisse AG, Cayman Islands Branch, as the Administrative Agent, the Collateral Agent and Viewpoint and (ii) Second Lien Grant of Security Interest in Trademark, dated as of July 21, 2017 (the “Trademark Security Agreement”), executed by the Grantors in favor of Collateral Agent and recorded with the United States Patent and Trademark Office on July 27, 2017 at Reel/Frame 6119/0149. Capitalized terms used herein and not otherwise defined have the meanings ascribed to such terms in the Trademark Security Agreement.


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby terminates and releases the Trademark Security Agreement and all liens and security interests granted by the Grantors in favor of the Collateral Agent pursuant to the Trademark Security Agreement, including (without limitation) all of its right, title and interest in, to and under the Collateral (including those Trademarks listed in Schedule A attached hereto), including the goodwill associated with such Trademarks and the right to receive all Proceeds therefrom.


The Collateral Agent hereby acknowledges that this document may be filed, along with any other necessary documentation, with the United States Patent and Trademark Office to evidence the termination and release granted herein. The Collateral Agent shall execute and deliver to any Grantor, at such Grantor’s expense, all documents that such Grantor shall reasonably request to evidence the terminations and releases effectuated herein.
