**TERMINATION AND RELEASE OF SECURITY INTEREST IN SECOND LIEN
INTELLECTUAL PROPERTY COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of August 9, 2018, is made by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as Administrative Agent (the “**Administrative Agent**”), under the Pledge Agreement and IP Agreements referred to below (capitalized terms used in this Release and not otherwise defined herein have the meaning set forth in the Pledge Agreement and the IP Agreements) in favor of the Grantors (as defined below).

W I T N E S S E T H

WHEREAS, in connection with that certain Second Lien Pledge and Security Agreement, dated as of December 20, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Pledge Agreement**”) by and among the Loan Parties party thereto and the Administrative Agent, the Grantors had granted a security interest to the Administrative Agent in the IP Collateral;

WHEREAS, pursuant to those certain Second Lien Intellectual Property Security Agreements described on Schedule I attached hereto (the “**IP Agreements**”), the Grantors granted, among other Collateral as set forth therein, continuing security interests in the IP Collateral (as defined in the IP Agreements), including the Trademarks, Patents and Copyrights listed on Schedule I attached hereto (the “**IP Collateral**”);

WHEREAS, the IP Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Schedule I hereto; and

WHEREAS, in accordance with the provisions of the Pledge Agreement and the IP Agreements, the indebtedness has been paid in full and the Grantors desire the Administrative Agent to terminate and release its security interest in and to the IP Collateral.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, hereby irrevocably **RELEASES**, terminates, cancels and discharges, without representation, recourse or warranty whatsoever, all of the Administrative Agent’s security interest and all other rights, title and interest in, to and under the IP Collateral, whether granted pursuant to the IP Agreements or any other agreement or document delivered in connection with the Pledge Agreement, and the Administrative Agent hereby reassigns, retransfers and reconveys any and all right, title and interest (if any) that the Administrative Agent may have in, to and under the IP Collateral to the Grantors.

The Administrative Agent agrees, at the Grantors’ expense, to cooperate with the Grantors to provide them with the information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent’s security interest in the released collateral described herein.

The Administrative Agent authorizes and requests that this Release be recorded with the U.S. Patent and Trademark Office.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
