RELEASE OF TRADEMARK SECURITY INTERESTS dated as of June 15, 2018 (this "Release"), by JPMORGAN CHASE BANK, N.A., as Agent (the "Agent"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Guaranty and Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of June 30, 2016 (as amended, restated, amended and restated, extended, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Springs Industries, Inc. (the "Borrower"), SIWF Acquisitions, Inc. ("Holdings"), the other Persons party thereto that are designated as "Credit Parties", JPMorgan Chase Bank, N.A., as agent (the "Agent") for the several financial institutions from time to time party thereto (collectively, the "Lenders" and individually each a "Lender"), and the Lenders and L/C Issuers from time to time party thereto, (ii) the Guaranty and Security Agreement dated as of June 30, 2016 (as amended, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement"), by and among the Borrower, Holdings, the Grantors listed therein and the Agent, (iii) the Trademark Security Agreement dated as of June 30, 2016, by and among the Grantors listed therein and the Agent and (iv) the Trademark Security Agreement dated as of April 14, 2017, by and among the Grantors listed therein and the Agent (such documents set forth in clauses (i) through (iv), the "Loan Documents").

B. Pursuant to the Loan Documents, the Persons listed on Schedule 1 hereto (the "Grantors") granted to the Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of the Grantors in the Trademark Collateral, including the trademarks and trademark applications of the Grantors set forth on Schedule I hereto (collectively, the "Trademarks"), which security interests were recorded with the United States Patent & Trademark Office on (i) July 29, 2016 at Reel/Frame 5843/0234 and (ii) April 18, 2017 at Reel/Frame 6037/0547.


C. Pursuant to the Payoff Letter dated as of June 15, 2018, among the Borrower and the Agent, the Agent agreed to release any and all security interests it may have in the Copyright Collateral pursuant to the Loan Documents.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby release, relinquish and discharge any and all security interests it has against the Trademark Collateral. The Agent agrees to make filings with the United States Patent and Trademark Office and other necessary filings, in each case reasonably requested by the Borrower and at the expense of the Borrower, to evidence the release and termination of the Agent's security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.


