**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of April 3, 2018, is made by **GOLDMAN SACHS BANK USA**, as Collateral Agent (in such capacity, the "Collateral Agent"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Credit Agreement, dated as of February 3, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among W. R. Grace & Co., a Delaware corporation ("**Holdings**"), W. R. Grace & Co.-Conn., a Connecticut corporation (the "Borrower"), Grace GmbH & Co. KG, a limited partnership under the laws of the Federal Republic of Germany registered with the local court Mainz under HRA 11357 (the "**German Borrower**"), the Lenders party thereto and Goldman Sachs Bank USA, as administrative agent and collateral agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the Borrower;

WHEREAS, the Borrower and the other Loan Parties entered into that certain Security Agreement dated as of February 3, 2014 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, in connection with the Credit Agreement, Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "IP Security Agreements"), the Borrower and certain other Loan Parties granted security interests in the certain intellectual property owned by Borrower and the other Loan Parties, including those listed on Annex I attached hereto (the "IP Collateral"); and

WHEREAS, the IP Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights, title and interest in and to the IP Collateral, together with (1) all proceeds and products of such IP Collateral, (2) the goodwill associated with such IP Collateral and (3) all causes of action arising prior to or after the date hereof for infringement of such IP Collateral or unfair competition regarding the same, and the Collateral Agent hereby reassigns to the applicable Loan Party any and all such rights, title and interest in and to such IP Collateral and related rights that the Collateral Agent may have.


The Collateral Agent agrees, at Borrower's expense, to cooperate with Borrower and to provide Borrower with the information and additional authorization reasonably required or reasonably desirable to effect the release of the Collateral Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
