

ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of June 29, 2018, (this "Assignment") is made by OWL ROCK CAPITAL CORPORATION, as Agent (in such capacity, the "Assignor") and FLFC LENDING CO., as successor agent (in such capacity, the "Assignee").

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated February 10, 2017 (the "Existing IP Grant"), Saje Natural Business, Inc., a Canadian corporation (the "Existing Grantor") granted to the Assignor a continuing security interest in and lien upon all of the Existing Grantor's intellectual property and intellectual property and applications set forth on Schedule A attached hereto (the "Existing IP");

WHEREAS, in conjunction with the Intellectual Property Security Agreement, Existing Grantor executed a Trademark Security Agreement, dated February 10, 2017, in favor of Assignor that was recorded on February 10, 2017 with the United States Patent and Trademark Office (the "USPTO") at Reel 005987, Frame 0153;

WHEREAS, among others, the Assignor, the Assignee, and the Existing Grantor have entered into that certain Assignment Agreement, dated as of the date hereof (the "Assignment Agreement"), whereby the Assignor transferred to the Assignee, among other things, all of the Assignor's rights and obligations under the Existing IP Grant and the Trademark Security Agreement;

WHEREAS, the Assignor wishes to confirm the details of the Assignment Agreement and transfer all of its rights and obligations under the Existing IP Grant and the Trademark Security Agreement to the Assignee, and the Assignee wishes to obtain from the Assignor, all of the Assignor's rights and obligations under the Existing IP Grant and the Trademark Security Agreement, including the secured rights in the Existing IP; and

WHEREAS, Grantor, certain of Grantor's affiliates and the Assignee have entered into the Assignment Agreement, pursuant to which Existing Grantor has reaffirmed its grant to the Assignor of a continuing security interest in, among other collateral, the Existing IP;

NOW THEREFORE; FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, the Assignor hereby assigns, transfers and sets over to the Assignee without recourse and without any representation or warranty of any kind, nature or description, and the Assignee hereby assumes from the Assignor, the Assignor's entire right, title and interest in and to the Existing IP Grant and the Trademark Security Agreement, and to the secured rights in and to the intellectual property listed therein and in and to the Existing IP.


