#### NOTICE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

Reference is made to (i) that certain Credit Agreement dated as of March 11, 2015, by and among Argos Holdings Inc., PetSmart, Inc. (the "Borrower"), the lenders from time to time party thereto (the "Lenders"), Citibank, N.A. ("Citibank") as Administrative Agent (in such capacity, "Administrative Agent", and as Collateral Agent, in such capacity, "Collateral Agent"), and each of the other parties from time to time party thereto (as may have been and may be further amended, supplemented or otherwise modified from time to time, the "Credit Agreement"); (ii) that certain Collateral Agreement dated as of March 11, 2015 among the Borrower, the other grantors party thereto and the Collateral Agent (as may have been and may be further amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"); (iii) that certain Trademark Security Agreement dated as of March 11, 2015 between Pet360, Inc. and the Collateral Agent (the "Pet360 Agreement"); (iv) that certain Trademark Security Agreement dated as of March 11, 2015 between PetSmart Store Support Group, Inc. and the Collateral Agent (the "PetSmart Store Support Agreement"); (v) that certain Trademark Security Agreement dated as of March 11, 2015 between PETMED, Inc. and the Collateral Agent (the "PETMED Agreement"); (vi) that certain Trademark Security Agreement dated as of May 31, 2017 between Chewy, Inc. and the Collateral Agent (the "Chewy Agreement"); and (vii) that certain Trademark Security Agreement dated as of June 30, 2017 among Pet360, Inc., PetSmart Home Office, Inc., AllPaws, Inc. and the Collateral Agent (the "June 2017 Agreement"; and together with the Pet360 Agreement, the PetSmart Store Support Agreement, the PETMD Agreement and the Chewy Agreement, each a "Trademark Security Agreement" and collectively, the "Trademark Security Agreements"). Capitalized terms used herein but not defined have the meanings given to them in the Credit Agreement.

WHEREAS, pursuant to the Collateral Agreement and (as applicable) each of the Trademark Security Agreements, the grantors party thereto granted to the Collateral Agent for the benefit of the Secured Parties a security interest in certain collateral including, without limitation, the trademark and service mark registrations and applications set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Pet360 Agreement was recorded with the United States Patent and Trademark Office (the "<u>USPTO</u>") on March 12, 2015 at Reel/Frame 5476/0498, the PetSmart Store Support Agreement was recorded with the USPTO on March 11, 2015 at Reel/Frame 5476/0041, the PETMED Agreement was recorded with the USPTO on March 11, 2015 at Reel/Frame 5476/0115, the Chewy Agreement was recorded with the USPTO on June 2, 2017 at Reel/Frame 6075/0849, and the June 2017 Agreement was recorded with the USPTO on June 30, 2017 at Reel/Frame 6096/0838;

WHEREAS, Citibank, as resigning Administrative Agent and as resigning Collateral Agent (the "Resigning Collateral Agent"), WILMINGTON TRUST, NATIONAL ASSOCIATION ("Wilmington Trust"), as successor Administrative Agent and as successor Collateral Agent (the "Successor Collateral Agent"), the Borrower, and the Lenders party thereto are parties to that certain Agency Assignment Agreement, dated as of August 16, 2018 (the "Agency Assignment Agreement"), pursuant to which (i) Citibank, resigned as Administrative Agent and as Collateral Agent under the Credit Agreement and each of the other Loan Documents, (ii) the Required Lenders appointed Wilmington Trust as the successor Administrative Agent and as the successor Collateral Agent under the Credit Agreement and the other Loan Documents, and (iii) the Borrower consented to such appointment and Wilmington Trust accepted such appointment; and

WHEREAS, the Resigning Collateral Agent and the Successor Collateral Agent have agreed to execute this Notice of Assignment of Security Interest in Trademarks (this "Notice") to evidence the assignment of the Resigning Collateral Agent's security interest in the Trademark Collateral for recordation with the USPTO.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the Resigning Collateral Agent and the Successor Collateral Agent hereby agree as follows:

The effective date of this Notice shall be August 16, 2018 (the "Effective Date").

Pursuant to the Agency Assignment Agreement, as of the Effective Date, (a) Wilmington Trust has succeeded to (by way of assignment) and will be vested with the rights, powers, privileges, discretions, indemnities, immunities, obligations and interests of Collateral Agent under each of the Trademark Security Agreements other than the Retained Rights (as defined in the Agency Assignment Agreement) (collectively, the "Trademark Collateral Agency Rights"), including with respect to all of the Collateral Agent's rights and interests as the secured party, on behalf of the Secured Parties, with respect to the Trademark Collateral and as the holder of any Lien therein and all rights under the Trademark Security Agreements, and (b) Citibank, in its capacity as Resigning Collateral Agent, assigns to the Successor Collateral Agent all of Citibank's rights, title, interest, duties and obligations in all of the Trademark Collateral Agency Rights (it being understood that Citibank shall continue to enjoy the Retained Rights), in each case, without any recourse, representations or warranties of any kind or nature.

From and after the Effective Date, each of the undersigned agrees (a) each reference in each Trademark Security Agreement to "Collateral Agent" shall mean and be a reference to Wilmington Trust, in its capacity as Successor Collateral Agent, (b) Wilmington Trust becomes vested with all of the rights, duties, obligations and other interests of the Collateral Agent under the Collateral Agreement and each Trademark Security Agreement, except to the extent otherwise expressly provided in the Agency Assignment Agreement, and (c) Citibank is discharged from its rights, duties, obligations and other interests as Collateral Agent under the Collateral Agreement and each Trademark Security Agreement, except to the extent otherwise expressly provided in the Agency Assignment Agreement.

This Notice is to provide notice of the assignment of the Trademark Collateral Agency Rights effected pursuant to the Agency Assignment Agreement, and each of the undersigned hereby acknowledges and agrees that the terms and provisions of such assignment are set forth in the Agency Assignment Agreement.

Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the Trademark Collateral originally granted to the Resigning Collateral Agent under the Trademark Security Agreements.
