The Commissioner of Patents and Trademarks is requested to issue any Certificate of Registration to CAN Technologies, Incorporated.

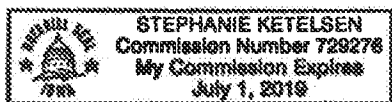
