AMENDED AND RESTATED TRADEMARK AND PATENT SECURITY AGREEMENT

THIS AMENDED AND RESTATED TRADEMARK AND PATENT SECURITY AGREEMENT (the "Agreement") made as of this 28th day of August, 2018 by MOUNT FRANKLIN FOODS, LLC, a Texas limited liability company ("Franklin) and HOSPITALITY MINTS LLC, a Delaware limited liability company ("Hospitality" and together with Franklin and each Person joined hereto as a grantor from time to time, collectively, the "Grantors", and each a "Grantor"), in favor of PNC BANK, NATIONAL ASSOCIATION ("PNC"), in its capacity as administrative agent for the Lenders (as defined below) (in such capacity, "Agent").

WITNESSETH

WHEREAS, Grantors and Mount Franklin Nutritionals, LLC, a South Carolina limited liability company (collectively, with each Person joined to the Credit Agreement (as defined below) as a borrower from time to time, collectively, the "Borrowers", and each a "Borrower") have entered into that certain Second Amended and Restated Revolving Credit, Term Loan, Equipment Loan and Security Agreement (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), dated as of the date hereof with the various financial institutions named therein or which hereafter become a party thereto as lenders (the "Lenders") and Agent, providing for the extensions of credit to be made to Borrowers by Lenders; and

WHEREAS, as security for the Obligations under the Credit Agreement, each Grantor has granted to Agent, for the benefit of Lenders, a security interest in substantially all of the assets of such Grantor, including all right, title and interest of each Grantor in, to and under all now owned and hereafter acquired trademarks and patents, together with the goodwill of the business symbolized by each Grantor's trademarks and patents and all products and proceeds thereof, to secure the payment of all amounts owing by Borrowers under the Credit Agreement.

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

- 1. <u>Incorporation of Credit Agreement</u>. The Credit Agreement and the terms and provisions thereof are hereby incorporated in their entirety by this reference. All terms capitalized but not otherwise defined herein shall have the same meanings ascribed to them in the Credit Agreement.
- 2. <u>Grant and Reaffirmation of Grant of Security Interests</u>. To secure the payment and performance of the Obligations under the Credit Agreement, each Grantor hereby grants to Agent, for its benefit and the benefit of Lenders, and hereby reaffirms its grant pursuant to the Credit Agreement of a continuing security interest in each Grantor's entire right, title and interest in and to the following whether now owned or existing or hereafter created, acquired or arising:

- (i) each trademark, trademark application, patent and patent application listed on <u>Schedule 1</u> annexed hereto (such trademarks and trademark applications, the "<u>Trademarks</u>" and such patents and patent applications, the "<u>Patents</u>"), together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (ii) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or Patent, or (b) injury to the goodwill associated with any Trademark
- 3. <u>Covenants.</u> Except as otherwise permitted under the Credit Agreement, each Grantor agrees not to sell, license, grant any option, assign or further encumber its rights and interest in the Trademarks or Patents without prior written consent of Agent.
- 4. <u>Representations and Warranties</u>. Each Grantor hereby represents and warrants that the Trademarks and Patents listed on <u>Schedule 1</u> attached hereto constitute all trademarks, trademark applications, patents and patent applications owned or registered to each Grantor as of the date of this Agreement.
- 5. <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any part hereto may execute this Agreement by signing and delivering one or more counterparts. Delivery by facsimile or electronic transmission shall bind the parties hereto. This Agreement constitutes supplemental terms to the rights and obligations under the Credit Agreement. In the event of any conflict between this Agreement (or any portion thereof) and the Credit Agreement, the terms of the Credit Agreement shall prevail.
- 6. <u>Governing Law</u>. THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF TEXAS APPLIED TO CONTRACTS TO BE PERFORMED WHOLLY WITHIN THE STATE OF TEXAS.
- 7. <u>Amendment and Restatement</u>. This Agreement amends and restates (but does not constitute an extinguishment or novation of) that certain Trademark and Patent Security Agreement, dated as of November 18, 2011, by Franklin in favor of Agent, as amended by that certain Supplement No. 1 to Trademark and Patent Security Agreement, dated as of November 10, 2016.
