RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release") is effective as of August 20, 2018, by U.S. BANK NATIONAL ASSOCIATION, solely in its capacity as collateral agent (in such capacity, "Secured Party") for the 8.00% Senior Secured Second Lien Convertible Notes issued by Layne Christensen Company.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, Secured Party hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Trademarks, without any recourse, representation or warranty, (ii) terminates the Security Agreement, and (iii) re-assigns to the Grantor, any right, title or interest the Secured Party may have in, to or under the Trademarks, together with the goodwill of the business symbolized thereby, and hereby authorizes the Grantor or the Grantor's authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination. Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction, solely at the expense of the Grantor, that the Grantor may reasonably require to effect the intent and purpose of this Release.
