## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of August 31, 2018 (this "Release"), is made by Antares Capital LP, in its capacity as collateral agent (the "Collateral Agent") for the secured parties, in favor of Tritech Software Systems, a California corporation ("Tritech"), Metro Technology Services, Inc., a Pennsylvania corporation ("Metro"), Admit Computer Services, Inc., a New York corporation ("Admit"), and Tiburon, Inc., a Virginia corporation ("Tiburon"). Each of Tritech, Metro, Admit and Tiburon are referred to herein individuals as a "Grantor" and collectively, as the "Grantors". Capitalized terms not otherwise defined in this Release shall have the meanings attributed to them in the Trademark Security Agreement (as defined below).

WHEREAS, Grantors are party to a First Lien Security Agreement, dated as of June 22, 2018 (as amended, restated, amended and restated, supplemented, or otherwise modified, replaced or refinanced from time to time, the "Security Agreement") in favor of the Collateral Agent.

WHEREAS, pursuant to the Security Agreement, Grantors executed and delivered the First Lien Grant of Security Interest In Trademark (the "Trademark Security Agreement"), dated as of June 22, 2018, in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on July 5, 2018 at Reel 6402, Frame 0599 (with respect to Tritech, as the Grantor), Reel 6401, Frame 0578 (with respect to Admit, as the Grantor), Reel 6401, Frame 0360 (with respect to Metro, as the Grantor), and Reel 6372, Frame 0479 (with respect to Tiburon, as the Grantor).

WHEREAS, pursuant to the Trademark Security Agreement, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of its right, title and interest in, to and under the following then owned or at any time thereafter acquired by such Grantor, or in which such Grantor then had or at any time thereafter acquired any right, title or interest, in each case, that are not Excluded Property: (i) all trademarks, service marks, trade names, brand names, domain names, corporate names, company names, business names, fictitious business names, trade dress, logos, other source or business identifiers and designs, then existing or thereafter adopted or acquired, all registrations and recordings thereof (if any), and all registrations and applications filed in connection therewith, including registrations and applications with the United States Patent and Trademark Office, including those U.S. registered trademarks and applications owned by such Grantor and listed on Schedule 1 attached hereto, and all extensions or renewals thereof, (ii) all goodwill associated therewith or symbolized thereby, (iii) all rights to sue at law or in equity for any past, present and future infringement, dilution, or other impairment or violation thereof, including the right to receive all Proceeds therefrom, and (iv) all other rights, priorities and privileges related thereto (collectively, the "Trademark Collateral").

WHEREAS, the Collateral Agent acknowledges that the conditions for termination of its security interest in the Trademark Collateral have been met, and accordingly, pursuant to Section 4 of the Trademark Security Agreement, the Collateral Agent has agreed to execute this Release.


NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent hereby releases and terminates in its entirety its lien on and security interest in and to the Trademark Collateral, and discharges, quit claims, and relinquishes unto each Grantor, and re-assigns to each Grantor, as

applicable, any and all right, title or interest it may have in, to, or under the Trademark Collateral of such Grantor.
