2. Associated hereby releases its security interest in the Trademarks, including without limitation the Trademarks set forth on Schedule 1 hereto.

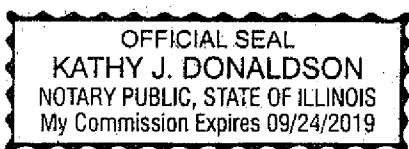
