### RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated effective as of October 12, 2018, is made by BANK OF AMERICA, N.A., as Administrative Agent (the "Assignor") for the several banks and other financial institutions or entities (the "Lenders") from time to time parties to the Second Amended Credit Agreement referred to below, and the Persons listed on the signature pages hereof (the "Assignees").

WHEREAS, JBS USA, LLC (the "<u>U.S. Borrower</u>"), JBS AUSTRALIA PTY LIMITED, the other Loan Parties, the several banks and other financial institutions or entities (the "<u>JBS Lenders</u>") and JPMORGAN CHASE BANK, NA., as administrative agent ("<u>JP Morgan</u>") for the JBS Lenders entered into a Second Amended and Restated Revolving Syndicated Facility, dated as of June 30, 2011 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "<u>Second Amended Credit Agreement</u>");

WHEREAS, in connection with the Second Amended Credit Agreement, SWIFT BRANDS COMPANY and SKIPPACK CREEK CORPORATION (collectively, the "Grantors") and certain affiliates of the Grantors entered into the Security Agreement (Other Collateral) dated June 30, 2011 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Existing Security Agreement (Other Collateral)") in favor of JP Morgan for the ratable benefit of the Secured Parties (as defined in the Second Amended Credit Agreement) pursuant to which the Grantors granted to JP Morgan a security interest in, among other property, certain trademarks and trademark applications of the Grantors;

WHEREAS, pursuant to the terms and conditions of the Existing Security Agreement (Other Collateral), the Grantors entered into the Short-Form Trademark Security Agreement dated June 30, 2011 (as amended, amended and restated supplemented or otherwise modified from time to time, the "Trademark Security Agreement") and recorded the Trademark Security Agreement on July 1, 2011 with the United States Patent and Trademark Office at Reel 4574 and Frame 0066 (together with the Existing Security Agreement (Other Collateral), the "Existing Security Agreements"), pursuant to which the Grantors granted to JP Morgan for the ratable benefit of the Secured Parties (as defined in the Second Amended Credit Agreement) a security interest in all of Grantors' right, title and interest in and to the following (the "Trademark Collateral"):

- (i) the trademark and service mark registrations and applications set forth in Schedule A hereto (provided that no security interest was granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law), together with the goodwill symbolized thereby (the "Trademarks");
  - (ii) all Proceeds and products of the Trademarks; and
- (iii) all rights to sue at law or in equity for any infringement, unfair competition or other impairment thereof, including the right to receive all proceeds and damages therefrom.

WHEREAS, JP Morgan and Assignor, in its capacity as successor Administrative Agent and the other parties thereto have entered into the Resignation and Appointment of Successor Agent and Australian Successor Agent Agreement dated as of August 15, 2014 (the "Substitution Agreement"), whereby JP Morgan transferred to Assignor all rights under the Existing Security Agreements;

WHEREAS, JP Morgan, Assignor, U.S. Borrower and the Grantors entered into that certain Trademark Security Agreement (the "Substitution Trademark Security Agreement") in order to confirm JP Morgan's transfer of its rights under the Existing Security Agreements to Assignor and that Assignor obtained from JP Morgan all JP Morgan's rights under the Existing Security Agreements including the secured rights in the Trademark Collateral. Pursuant to the Substitution Trademark Security Agreement, JP Morgan assigned, transferred, and set over to Assignor, JP Morgan's entire right, title and interest in, to and under the Existing Security Agreements and to JP Morgan's security interest in and to the Trademark Collateral, including but not limited to the trademarks and trademark applications on Schedule A, for Assignor's own use and enjoyment, and for the use and enjoyment of Assignor's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by JP Morgan as if the Substitution Trademark Security Agreement had not been made, together with all income, royalties, damages or payments due or payable as of the date thereof or thereafter;

WHEREAS, the Substitution Trademark Security Agreement was recorded on October 30, 2014 with the United States Patent and Trademark Office at Reel 5417 and Frame 0429;

WHEREAS, Grantors, certain affiliates of Grantors and Assignor have entered into the Amended and Restated Security Agreement (Other Collateral) (the "Amended Security Agreement"), dated as of August 15, 2014, pursuant to which the Grantors have reaffirmed their grant to Assignor, as successor Administrative Agent, of a continuing security interest in, among other collateral, the Trademark Collateral; and

WHEREAS, the Assignor and the Assignees desire that the Assignor terminate, release, and discharge fully its security interest in, all right, title and interest in and to the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby agrees with the Assignee as follows:

SECTION 1. <u>Defined Terms</u>. Unless otherwise defined herein, terms defined in the Trademark Security Agreement, Substitution Trademarks Security Agreement and the Amended Security Agreement, as applicable, and used herein have the meaning given to them in the Trademark Security Agreement, Substitution Trademarks Security Agreement and the Amended Security Agreement, as applicable.

SECTION 2. Release of Security Interest. The Assignor hereby terminates, releases and discharges fully its security interest in the Trademark Collateral, including, without limitation, the trademarks and trademark applications listed on Schedule A hereto, and reassigns and transfers any right, title and interest that the Assignor may have in the Trademark Collateral to the Assignees. The Assignor hereby acknowledges and agrees that the Substitution Trademark Security Agreement is terminated.

SECTION 3. <u>Recordation.</u> The Assignor hereby authorizes the Assignees or the Assignees' authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Assignor in the Trademark Collateral, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.

SECTION 4. Further Assurances. The Assignor hereby agrees to execute and deliver to any Assignee all termination statements, releases and similar documents that such Assignee (or its respective agent or designee) shall reasonably request in order to confirm this Release and such Assignee's right, title, and interest in or to the Trademark Collateral, at such Assignee's sole cost and expense.

SECTION 5. Execution in Counterparts. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Release by facsimile or an electronic transmission of a .pdf copy thereof shall be effective as delivery of an original executed counterpart of this Release.

SECTION 6. Governing Law. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
