INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Agreement”) made as of this 11th day of October, 2018 by TRANSTAR INDUSTRIES LLC, an Ohio limited liability company, TRANSTAR AUTOBODY TECHNOLOGIES LLC, an Ohio limited liability company, AXIOM AUTOMOTIVE TECHNOLOGIES LLC, a Delaware limited liability company, ETX TRANSMISSIONS LLC, a Delaware limited liability company, ALMA PRODUCTS I LLC, a Michigan limited liability company, ATCO PRODUCTS LLC, a Delaware limited liability company, and DACCO LLC, an Ohio limited liability company and TRANS MART, INC., a Puerto Rico corporation (collectively, the “Grantors”, and each a “Grantor”), in favor of PNC BANK, NATIONAL ASSOCIATION (“PNC”), in its capacity as agent for the Lenders (“Agent”).

W I T N E S S E T H

WHEREAS, TRANSTAR HOLDING COMPANY LLC, a Delaware limited liability company (“Transtar Holdings”, together with each of its Subsidiaries party to the Loan Agreement (as defined below) as Borrowers from time to time and each Guarantor party to the Loan Agreement from time to time, collectively, the “Loan Parties”, and each a “Loan Party”) have entered into that certain Revolving Credit and Security Agreement dated as of the date hereof among the Loan Parties, the financial institutions which are now or which hereafter become a party thereto (collectively, the “Lenders” and each individually a “Lender”) and Agent (as amended, restated, supplemented, or replaced from time to time, the “Loan Agreement”), whereby Lenders agreed to make certain financial accommodations available to the Loan Parties from time to time pursuant to the terms and conditions thereof;

WHEREAS, as security for the Obligations under the Loan Agreement, each Grantor has granted to Agent, for the benefit of Lenders, a security interest in substantially all of the assets of such Grantor including all right, title and interest of such Grantor in, to and under all now owned and hereafter acquired trademarks, copyrights and patents, together with the goodwill of the business symbolized by such Grantor’s trademarks, copyrights and patents and all products and proceeds thereof, to secure the payment of all amounts owing by Loan Parties under the Loan Agreement;

WHEREAS, it is understood that the relative rights and priorities of Agent in respect of the Collateral are governed by that certain Intercreditor Agreement dated as of the hereof among Agent, The Bank of New York Mellon, in its capacity as agent for the Senior Secured Loan Secured Parties (as defined therein), and The Bank of New York Mellon, in its capacity as agent for the First Lien Term Loan Secured Parties (as defined therein) (as amended, restated, supplemented or replaced from time to time, the “Intercreditor Agreement”).

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

1. Incorporation of Loan Agreement. The Loan Agreement and the terms and provisions thereof are hereby incorporated in their entirety by this reference. All terms

capitalized but not otherwise defined herein shall have the same meanings ascribed to them in the Loan Agreement.

2. Grant and Reaffirmation of Grant of Security Interests. To secure the payment and performance of the Obligations under the Loan Agreement, each Grantor hereby grants to Agent, for the benefit of itself and Lenders, and hereby reaffirms its prior grant pursuant to the Loan Agreement of a continuing security interest in such Grantor's entire right, title and interest in and to the following whether now owned or existing or hereafter created, acquired or arising:

(i) each trademark, trademark application, copyright, copyright application, each patent and patent application listed on Schedule 1 annexed hereto (such trademarks and trademark applications, the "Trademarks"; such copyrights and copyright applications, the "Copyrights"; and such patents and patent applications, the "Patents"), in each case, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; provided, however, that no security interest shall be granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications or the marks that are the subject thereof under applicable federal law; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by any Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, Copyright or Patent, or (b) injury to the goodwill associated with any Trademark.

3. Covenants. Except as otherwise permitted under the Loan Agreement and the Intercreditor Agreement, each Grantor agrees not to sell, license, grant any option, assign or further encumber its rights and interest in the Trademarks, Copyrights or Patents without prior written consent of Agent.

4. Representations and Warranties. Each Grantor hereby represents and warrants that the Trademarks, Copyrights and Patents listed on Schedule 1 attached hereto constitute all trademarks, trademark applications, copyrights, copyright applications, patents and patent applications owned or registered to such Grantor as of the date of this Agreement.

5. Authorization To Supplement. If any Grantor shall obtain rights to any new Trademarks, Patents or Copyrights, this Agreement shall automatically apply thereto, except to the extent excluded pursuant to Section 2(i) above. Without limiting any Grantor's obligations under this Section 5, Grantor hereby authorizes Agent unilaterally to modify this Agreement by amending Schedule 1, to include any such new Trademarks, Patents or Copyrights of any Grantor identified in a written notice provided by a Grantor. Notwithstanding the foregoing, no failure to so modify this Agreement or amend Schedule 1 hereto shall in any way affect, invalidate or detract from Agent's continuing security interest in all Trademarks, Patents or Copyrights, whether or not listed on the schedules hereto.

6. Counterparts. This Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Agreement by signing and delivering one or more counterparts. Delivery by facsimile or electronic transmission shall bind the parties hereto.

7. Governing Law. This Agreement and the transactions contemplated hereby, and all disputes between the parties under or relating to this Agreement or the facts or circumstances leading to its execution, whether in contract, tort or otherwise shall be governed by and construed in accordance with the laws of the State of New York.


8. Intercreditor Agreement. Notwithstanding any other provision contained herein, this Agreement, the Liens created hereby and the rights, remedies, duties and obligations provided for herein are subject in all respects to the provisions of the Intercreditor Agreement. In the event of any conflict or inconsistency between the provisions of this Agreement and the Intercreditor Agreement that relates solely to the rights or obligations of, or relationship between, Agent and the Lenders on the one hand, and the Senior Secured Loan Secured Parties and the First Lien Term Loan Secured Parties on the other hand (as each such term is defined in the Intercreditor Agreement), the provisions of the Intercreditor Agreement shall control.

9. Termination. This Agreement and the Liens and security interests granted hereunder shall automatically terminate upon a termination of the Loan Agreement pursuant to and in accordance with Article 13 thereof.




