INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated as of October 31, 2018, is entered into by and between P.H. Glatfelter, a Pennsylvania corporation, located at 96 South George Street, Suite 500, York, PA 17401 (the "Assignor"), in favor of Pixelle Specialty Solutions LLC (formerly known as Spartan Paper LLC), a Delaware limited liability company located at 228 South Main Street, Spring Grove, PA 17362 (the "Assignee").

WHEREAS, the Assignor and the Assignee have entered into that certain Asset Purchase Agreement, dated as of August 21, 2018 (together with all exhibits and schedules thereto, the "APA"), pursuant to which and among other things (a) at the Closing, the Assignor shall sell, transfer, convey, assign and deliver, to the Purchaser, and the Purchaser shall purchase, acquire and accept from the Seller, all right, title and interest of the Seller in, to and under the Purchased Assets, and (b) the Purchaser shall, from and after the Closing, assume and agree to pay, perform and discharge when due any and all of the Assumed Liabilities, in each of clauses (a) and (b), upon the terms and subject to the conditions set forth in the APA; and

WHEREAS, in connection with the APA, the Assignor has agreed to sell, assign, transfer and deliver to the Assignee among other assets, all of Assignor's rights, title and interest in (i) the patents (including all provisionals, reissues, divisions, continuations, continuations-in-part, reexaminations and extensions thereof) and patent applications as set forth in Schedule 1 (the "Assigned Patents") and (ii) the trademark registrations and applications for trademark registration set forth in Schedule 2 (the "Assigned Trademarks").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor and the Assignee agree as follows:

SECTION 1. Definitions. Capitalized terms used but not defined herein have the meanings ascribed to such terms in the APA.

SECTION 2. Assignment. Assignor hereby sells, assigns, transfers and delivers to the Assignee, and the Assignee hereby accepts the sale, assignment, transfer and delivery of, all of Assignor's right, title and interest in, to and under the:

(a) Assigned Patents together with all the rights of enforcement and the rights, interests, claims and demands recoverable in law or equity, that Assignor has or may have in profits and damages for past, present and future infringements or other conflicts relating to the Assigned Patents, including, without limitation, the right to compromise, sue for and collect such profits and damages; all rights of priority resulting from the filing of the Assigned Patents, and all other rights, including common law rights, relating to the Assigned Patents, to the extent such rights exist or may exist in the future, each to be held and enjoyed by the Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives as said rights would have

been held and enjoyed by the Assignor had this assignment and sale not been made; provided, however, that this Assignment shall not constitute an assignment to the extent that, if it were to sell, transfer, assign or deliver an interest in and to the Assigned Patents, it would impair the subsequent lawful and effective execution and recordation of a necessary country-specific form of assignment; and

(b) the Assigned Trademarks together with all the goodwill associated with the use of or symbolized by the Assigned Trademarks; all rights of enforcement and the rights, interests, claims and demands recoverable in law or equity, that Assignor has or may have in profits and damages for past, present, and future infringements, unfair competition, passing off or other conflicts relating to the Assigned Trademarks, including, without limitation, the right to compromise, sue for and collect such profits and damages; all rights of priority resulting from the filing of the Assigned Trademarks, and all other rights, including common law rights, relating to the Assigned Trademarks, to the extent such rights exist or may exist in the future, each to be held and enjoyed by the Corresponding Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives as said rights would have been held and enjoyed by such Assignor had this assignment and sale not been made.

SECTION 3. Recordation. The Assignor hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks the United States Patent and Trademark Office and other empowered officials of the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by the Assignee.

SECTION 4. Further Assurances. At the request of the Assignee, Assignor shall execute and deliver, or cause to be executed and delivered, such documents as the Assignee or its counsel may reasonably request to further effectuate or evidence the transactions set forth in this Assignment.

SECTION 5. Subject to APA. This Assignment is made pursuant to, and is subject to the terms of, the APA. Nothing contained in this Assignment is intended to or shall be deemed to limit, restrict, modify, alter, amend or otherwise change in any manner the rights and obligations of the parties under the APA, and in the event of any conflict between the terms and provisions hereof and the terms and provisions of the APA, the terms and provisions of the APA shall control.

SECTION 6. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute one and the same agreement. A signed copy of this Assignment delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.


SECTION 7. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware without giving effect to
