INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "IP Assignment Agreement"), dated as of February 9, 2018, is made by and among TI Golf Holdings Inc., a Delaware corporation, SirenServ, Inc., an Illinois corporation (each a "Seller" and, collectively, the "Sellers") and EB Golf Media LLC, a Delaware limited liability company (the "Buyer"). The Sellers and the Buyer shall be referred to herein from time to time as the "Parties" and each, a "Party." Capitalized terms used herein but not otherwise defined shall have the respective meanings ascribed to such terms in the Asset Purchase Agreement (as defined below).

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of February 6, 2018, by and among the Sellers, the Buyer, solely with respect to Section 9.16 thereof, Emigrant Capital Corp., a Delaware corporation, and, solely with respect to Section 9.17 thereof, Time Inc., a Delaware corporation (the "Asset Purchase Agreement"), the Sellers have agreed to transfer, assign, and deliver to the Buyer the Acquired Assets and the Buyer has agreed to purchase and acquire the Acquired Assets, all in accordance with the terms set forth in the Asset Purchase Agreement; and

WHEREAS, pursuant to the Asset Purchase Agreement, *inter alia*, the Sellers have agreed to assign to the Buyer and the Buyer has agreed to acquire from the Sellers, those certain domain names, trademarks, and copyrights set forth therein (such domain names, trademarks, and copyrights constituting a part of the Acquired Assets) (as also listed on Exhibit A, Exhibit B, and Exhibit C hereto).

NOW, THEREFORE, in consideration of the premises and mutual promises contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Parties hereby agree as follows:

1. Assignment. Each Seller, as applicable, hereby transfers and assigns to the Buyer the following:

a. the Internet domain names listed on Exhibit A hereto (the "Assigned Domain Names");

b. all unregistered and registered trademarks and service marks, trademark and service mark applications, common law trademarks and service marks, trade dress and logos, trade names, business names, corporate names, product names and other source or business identifiers and the goodwill associated with any of the foregoing and any renewals and extensions of any of the foregoing of such Seller used primarily in the Business, including those listed on Exhibit B hereto (the "Assigned Trademarks");

c. all copyrights and all other rights with respect to works of authorship, and all copyright registrations thereof and applications therefor and renewals, extensions and reversions thereof, and all other rights corresponding thereto throughout the world (including all moral and economic rights, however denominated) of such Seller used primarily in the Business, including those listed on Exhibit C (the "Assigned Copyrights," and, together with the Assigned Domain Names and Assigned Trademarks, the "Assigned IP");

d. all rights of any kind whatsoever of the Sellers accruing under any of the Assigned IP provided by Applicable Law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

e. any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the Assigned IP; and

f. any and all claims and causes of action arising out of, or otherwise in respect of the Assigned IP, whether or not pending or threatened as of the Closing and whether or not accrued as of the Closing, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief, or otherwise recover any such damages.

2. Recordation and Further Actions.

a. Each Seller, as applicable, hereby authorizes and requests the Commissioner for Trademarks in the United States Patent and Trademark Office and the Register of Copyrights in the United States Copyright Office, and the officials of corresponding entities or agencies in any applicable jurisdictions throughout the world to record and register this IP Assignment Agreement upon request by the Buyer.

b. Following the Closing, upon the Buyer's request, each Seller, as applicable, will take such steps and actions, and provide such cooperation and assistance to the Buyer and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned IP to the Buyer, or any assignee or successor thereto. The transfer and assignment of the Assigned Domain Names shall be deemed to have been perfected for purposes of the preceding sentence when: (i) the Buyer's registrar has confirmed the transfer; (ii) the applicable WHOIS database identifies the Buyer or the Buyer's representative as the registrant of the Assigned Domain Names; and (iii) the Buyer has administrative and technical access to the Assigned Domain Names and sole control over the locations to which the Assigned Domain Names refer visitors.

3. Limited Power of Attorney. Each Seller, as applicable, hereby appoints the Buyer as the true and lawful attorney-in-fact of such Seller, with full power of substitution, having full rights and authority, in the name of such Seller to do all such acts and things in relation to the matters set forth in Section 2(a) of this IP Assignment Agreement as the Buyer shall reasonably deem desirable. Each Seller, as applicable, agrees that the above-stated powers are coupled with an interest and shall be irrevocable by such Seller.

4. Terms of the Asset Purchase Agreement. This IP Assignment Agreement is intended to evidence the consummation of the transfer and assignment by the Sellers to the Buyer of the Assigned IP, as contemplated by the Asset Purchase Agreement and pursuant to the terms thereof which are hereby incorporated by reference into this IP Assignment Agreement. Each Seller and the Buyer, by their execution of this IP Assignment Agreement, each hereby acknowledges and agrees that neither the representations and warranties nor the rights and

remedies of any Party under the Asset Purchase Agreement shall be deemed to be enlarged, modified, or altered in any way by this IP Assignment Agreement. In the event of any inconsistencies or ambiguities between this IP Assignment Agreement and the Asset Purchase Agreement, the terms of the Asset Purchase Agreement shall govern.

5. Miscellaneous. This IP Assignment Agreement shall inure to the benefit of the Parties and their respective successors and assigns, and shall be binding upon and enforceable against the Parties and their respective successors and assigns. This IP Assignment Agreement shall be governed by and construed in accordance with the laws of the State of New York, without giving effect to any choice of law or conflict of law provision or rule (whether of the State of New York or any other jurisdiction) that would cause the application of the law of any jurisdiction other than the State of New York. Neither Buyer nor Sellers intend that this IP Assignment Agreement shall benefit or be enforceable by any Person other than Buyer and Sellers and their respective successors and permitted assigns.


6. Counterparts. This IP Assignment Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this IP Assignment Agreement by facsimile or scanned page shall be as effective as delivery of a manually executed counterpart to this IP Assignment Agreement.



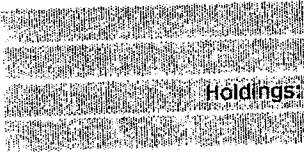
