RELEASE OF TRADEMARK SECURITY INTEREST dated as of November 6, 2018 (this "Release"), by GOLDMAN SACHS BANK USA ("Goldman Sachs"), as Collateral Agent (the "Collateral Agent"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Pledge and Security Agreement, as applicable, referred to below.

A. Reference is made to (a) the Term Credit and Guaranty Agreement dated as of April 30, 2014 (as amended, the "Credit Agreement"), among Entegris, Inc., a Delaware corporation (the "Borrower"), certain subsidiaries of the Borrower party thereto, the Lenders party thereto and Goldman Sachs, as administrative agent and collateral agent, (b) the Term Pledge and Security Agreement dated as of April 30, 2014 (as amended, the "Pledge and Security Agreement"), among the Borrower, the Guarantors party thereto and the Collateral Agent and (c) the Grant of Security Interest in United States Trademarks dated as of April 30, 2014 (as amended, the "Grant" and, together with the Pledge and Security Agreement, the "Security Agreements"), among Entegris, Inc., Poco Graphite, Inc., Advanced Technology Materials, Inc., ATMI Packaging, Inc. (together with Entegris, Inc., Poco Graphite, Inc. and Advanced Technology Materials, Inc., the "Grantors") and the Collateral Agent.

B. Pursuant to the Security Agreements, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the trademarks of the Grantors set forth on Schedule I hereto (the "Trademarks"), which security interest was recorded with the United States Patent and Trademark Office on May 2, 2014 at Reel 5272 Frame 649.

C. In connection with the payment and discharge of all Obligations of the Borrower and the other Credit Parties and the termination of all Commitments under the Credit Agreement, the Grantors have informed the Collateral Agent of their desire that the Collateral Agent, on behalf of the Secured Parties, release all right, title and interest granted to it, for the ratable benefit of the Secured Parties, under the Security Agreements in and to the Trademarks.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges any and all security interests it has in the Trademarks and reassigns all right, title and interest it has in the Trademarks, together with the goodwill associated therewith, to the applicable Grantor. The execution and delivery of this Release and the performance of any actions by the Collateral Agent are made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.


