## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN)

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of November 9, 2018 (the "Effective Date"), is made by Bank of America, N.A., as Collateral Agent, (in such capacity, together with its successors and permitted assigns, the "Second Lien Collateral Agent"), in favor of Red Ventures, LLC, MyMove, LLC, Soda, LLC, Bankrate, Inc., Bankrate, LLC, LinkOffers, Inc. and Allconnect, Inc.(each a "Grantor" and, collectively, the "Grantors").

WHEREAS, pursuant to that certain Second Lien Collateral Agreement, dated as of November 8, 2017, by and among the Second Lien Collateral Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Second Lien Collateral Agreement"), the Grantors granted to the Second Lien Collateral Agent, in its capacity as Second Lien Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Second Lien Collateral Agreement, the Grantors executed and delivered a Second Lien Trademark Security Agreement, dated as of November 8, 2017 (the "Second Lien Trademark Security Agreement"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Second Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 10, 2017 at Reel/Frame 006201 0432;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Second Lien Collateral Agent hereby agrees as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Second Lien Collateral Agreement or the Trademark Security Agreement, as applicable.
- 2. Release. The Second Lien Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth Schedule I attached hereto, arising under the Second Lien Collateral Agreement and the Second Lien Trademark Security Agreement. If and to the extent that the Second Lien Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Second Lien Trademark Security Agreement, the Second Lien Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and reassigns such right, title or interest to the Grantors.
- 3. <u>Termination</u>. The Second Lien Collateral Agent, without representation or warranty of any kind, terminates and cancels the Second Lien Trademark Security Agreement.
- 4. <u>Further Assurances</u>. The Second Lien Collateral Agent agrees to take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release. Second Lien Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Release.
- 5. <u>Governing Law</u>. This Release shall be construed in accordance with and governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
