TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "<u>Trademark Agreement</u>") is made as of this 19th day of November, 2018, among Tops Markets, LLC and Tops PT, LLC (collectively, jointly and severally, the "Grantors" and each individually the "Grantor") and Bank of America, N.A., in its capacity as collateral agent for the Credit Parties (together with its successors, "<u>Collateral Agent</u>").

WHEREAS, Grantor has executed and delivered to Collateral Agent, for the benefit of the Credit Parties, that certain Guarantee and Security Agreement dated as of November 19, 2018 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, Grantor is required to execute and deliver to Collateral Agent, for the benefit of the Credit Parties, this Trademark Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

1. <u>DEFINED TERMS</u>. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

2. GRANT OF SECURITY INTEREST IN TRADEMARK

<u>COLLATERAL</u>. Grantor hereby pledges and grants to Collateral Agent, for its own benefit and for the benefit of the other Credit Parties, a lien on and security interest in all of the right, title and interest of Grantor in, to and under the following (collectively, the "<u>Trademark Collateral</u>"):

- (a) all of Grantor's United States Trademarks including those referred to on Schedule I hereto, including the goodwill exclusively symbolized thereby, provided that no security interest shall be granted in any United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable law;
 - (b) all renewals of the foregoing; and
- (c) all proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement or dilution of any United States Trademark.
- 3. <u>SECURITY FOR OBLIGATIONS</u>. This Trademark Agreement secures, and the Trademark Collateral is collateral security for, the payment and performance in full when due of the Secured Obligations.

- 4. <u>SECURITY AGREEMENT</u>. The security interests granted pursuant to this Trademark Agreement are granted in conjunction with the security interests granted to Collateral Agent, for the benefit of the Credit Parties, pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
- 5. <u>COUNTERPARTS</u>. This Trademark Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Trademark Agreement by telecopy or other electronic transmission (e.g. "pdf") shall be as effective as delivery of a manually executed counterpart of this Trademark Agreement.
- 6. <u>CONSTRUCTION</u>. The rules of interpretation adopted in Section 1.2 of the Security Agreement shall be applicable to this Trademark Agreement.
- 7. <u>INTERCREDITOR AGREEMENT</u>. Notwithstanding anything to the contrary contained herein, the lien and security interest granted to the Collateral Agent pursuant to this Trademark Agreement and the exercise of any right or remedy by the Collateral Agent hereunder is subject to the provisions of the Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and the terms of this Trademark Agreement, the terms of the Intercreditor Agreement shall govern and control.
- 8. <u>GOVERNING LAW</u>. This Trademark Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.
