**TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST (this “Termination and Release”) is made as of the 20<sup>th</sup> of November, 2018, by CIT BANK, N.A., as administrative agent for the Lenders (in such capacity, the “Agent”) to INTERNATIONAL DESIGNS CORPORATION, LLC, a Florida limited liability company (the “Grantor”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Credit Agreement (as defined in the Security Agreement referenced below), the Security Agreement (defined below) or the Trademark Security Agreement (defined below), as applicable.

WHEREAS, pursuant to that certain Guarantee and Security Agreement, dated as of July 14, 2016, as supplemented by that certain Agreement to be Bound by Guarantee and Security Agreement dated as of February 9, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by the Grantor and the other parties thereto in favor of the Agent, the Grantor executed that certain Trademark Security Agreement, dated as of February 9, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on February 23, 2017, at Trademark Reel 5993 Frame 0608, pursuant to which the Grantor granted a security interest to the Agent, for the benefit of the Lenders, in the Marks, including certain trademarks and/or trademark applications listed on Schedule I hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Marks and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. the Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the Marks, including those trademarks set forth on Schedule I.
2. if and to the extent that Agent has acquired any right, title or interest in or to any of the Marks, the Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of the Agent’s right, title, and interest in and to the Marks, along with any goodwill in the Marks that the Agent may have acquired.


