TRADEMARK SECURITY AGREEMENT

This Trademark Security Agreement ("Agreement") dated October 29, 2018 (the "Effective Date") is given by ABSOPURE WATER COMPANY LLC, a Michigan limited liability company ("Grantor"), whose address is 8835 General Dr., Plymouth, Michigan 48170 in favor of FIFTH THIRD BANK, an Ohio baking corporation ("Bank"), whose address is One Woodward Avenue, Suite 2600, Detroit, Michigan.

WHEREAS, Grantor has entered into that certain Business Loan Agreement dated as of October 29, 2018 with Bank (as may be further amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), and concurrently therewith that certain Security Agreement of even date therewith (the "Security Agreement");

WHEREAS, pursuant to the Loan Agreement, the Grantor is required to execute and deliver this Agreement and to grant to the Bank a continuing security interest in all of the Trademark Collateral (as defined below) to secure all Obligations and liabilities from time to time owing under and pursuant to the Loan Agreement and the other Loan Documents; and

WHEREAS, Grantor has duly authorized the execution, delivery and performance of this Agreement.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor agrees, for the benefit of Bank, as follows:

- 1. **Definitions.** Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided in the Loan Agreement.
- 2. **Grant of Security Interest.** Grantor hereby grants to Bank a continuing security interest in all of Grantor's right, title and interest throughout the world, whether now or hereafter existing or acquired by Grantor, in and to the following ("Trademark Collateral"):
- (a) (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos and other source or business identifiers, and all goodwill of the business associated therewith, now existing or hereafter adopted or acquired, whether currently in use or not, all registrations and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office and corresponding offices in other countries of the world or otherwise, and all common Law rights relating to the foregoing, and (ii) the right to obtain all reissues, extensions or renewals of the foregoing (collectively referred to as "Trademarks"), including those Trademarks referred to in Exhibit A;
- (b) all of the goodwill of the business connected with the use of, and symbolized by the Trademarks described in clause (a);
- (c) the right to sue third parties for past, present and future infringements or dilution of the Trademarks described in clause (a) or for any injury to the goodwill associated with the use of any such Trademark; and
- (d) all proceeds of, and rights associated with, the foregoing (including proceeds, licenses, royalties, income, payments, claims, damages and proceeds of infringement suits).

- 3. **Security Agreement.** This Agreement has been executed and delivered by Grantor for the purpose of registering the security interest of Bank in the Trademark Collateral with the United States Patent and Trademark Office and corresponding offices in other countries of the world. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to Bank for its benefit under the Loan Agreement. The Loan Agreement (and all rights and remedies of Bank thereunder) shall remain in full force and effect in accordance with its terms.
- 4. **Acknowledgement.** Grantor does hereby further acknowledge and affirm that the rights and remedies of Bank with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. Notwithstanding any of the foregoing, nothing in this Agreement or the Loan Documents shall be deemed to require Grantor to use or maintain any Trademarks that it reasonably determines are no longer useful or necessary for the conduct of its business in the ordinary course. Grantor may elect to abandon, allow any applicable registration to lapse, or take similar action (or inaction) in its reasonable discretion with respect to any such Trademarks.
- 5. **Loan Document.** This Agreement is a Loan Document executed pursuant to the Loan Agreement and shall (unless otherwise expressly indicated herein) be construed, administered and applied in accordance with the terms and provisions thereof.
- 6. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY THE LAWS OF THE STATE OF MICHIGAN, WITHOUT GIVING EFFECT TO ANY CONFLICT OF LAW PRINCIPLES (BUT GIVING EFFECT TO FEDERAL LAW RELATING TO NATIONAL BANKS).
- 7. **Counterparts.** This Agreement may be executed in counterparts, each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of a signature page of any this Agreement by telecopy or other electronic means shall be effective as delivery of a manually executed counterpart of this Agreement.
- 8. **Entire Agreement.** THIS AGREEMENT AND THE OTHER LOAN DOCUMENTS REPRESENT THE FINAL AGREEMENT AMONG THE PARTIES AND MAY NOT BE CONTRADICTED BY EVIDENCE OF PRIOR, CONTEMPORANEOUS, OR SUBSEQUENT ORAL AGREEMENTS OF THE PARTIES. THERE ARE NO UNWRITTEN ORAL AGREEMENTS AMONG THE PARTIES.
