## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Agreement"), effective on the last date of execution set forth below, is made by and between William R. Davis, an individual with an address at 99 Biltmore Avenue, Rye, New York 10580 ("Davis") and Niklas R. Waltasaari, an individual with an address at 2470 SW Bobalink Ct., Palm City, Florida 34990 ("Waltasaari") (Davis and Waltasaari together, "Assignors"), and Paramount Products 1 LLC, a private company with an address at 51 Route 100, Briarcliff Manor, NY 10510 ("Assignee") (individually a "Party," and collectively, "the Parties").

WHEREAS, the Parties have agreed that Assignors shall convey, transfer, and assign the trademark listed on Schedule A ("the Mark") annexed hereto and made a part hereof.

NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignors, for themselves and their predecessors in title, if any, hereby convey, transfer, assign, deliver, and contribute to Assignee: (a) any and all of Assignors' right, title, and interest in and to the Mark set forth on Schedule A attached hereto, and all goodwill of the business symbolized by the Mark; (b) any and all income, royalties, damages, and payments hereafter due or payable to Assignors with respect to the Mark, including without limitation, damages and payments for past or future infringements and misappropriations of the Mark; and (c) any and all rights to sue for past, present, and future infringements or misappropriations of the Mark.

2. Miscellaneous.

(a) In furtherance of the Agreement, Assignors acknowledge that, from this date forward, the Assignee has succeeded to any and all of Assignors' right, title, and standing to: (i) receive all rights and benefits pertaining to the Mark; (ii) institute and prosecute all suits and proceedings and take all actions that the Assignee, in its sole discretion, may deem necessary or proper to collect, assert, or enforce any claim, right, or title of any kind in and to the Mark; and (iii) defend and compromise any and all such actions, suits, or proceedings relating to such transferred and assigned rights, title, interest, and benefits, and do all other such acts and things in relation thereto as the Assignee, in its sole discretion, deems advisable.

(b) Assignors hereby covenant and agree to promptly do, execute, acknowledge, and deliver, or cause to be done, executed, acknowledged, and delivered, all such other and further acts, assignments, transfers, assurances, and instruments as Assignee may reasonably request in order to effectuate and perfect the assignment contemplated by this Agreement and to otherwise secure in Assignee's name the Mark.

(c) This Agreement shall inure to the benefit of, and be binding upon, the Parties hereto together with their respective successors and assigns. This Agreement may be executed in counterparts. Photocopies or facsimile transmissions of signatures shall be deemed original signatures and shall be fully binding on the Parties to the same extent as original signatures.


