ASSIGNMENT OF INTELLECTUAL PROPERTY AGREEMENT

This Assignment of Intellectual Property Agreement (“Assignment”) is made and effective as of this 7th day of December, 2018 (the “Effective Date”), by and among **CARDINAL SYSTEMS, INC.**, a Pennsylvania corporation (“Assignee”) and **FOX POOL CORPORATION**, a Pennsylvania corporation (“Assignor”).

Background

A. Under the terms of a certain Asset Purchase Agreement by and among Assignee, Assignor, Fox Pool Canada Limited, a corporation incorporated under the laws of the Province of Ontario, Canada (“**Fox Canada**”), and Wexco Incorporated, the sole shareholder of Assignor and Fox Canada, dated October 26, 2018 (the “**Purchase Agreement**”), Assignor has conveyed, transferred, and assigned to Assignee, among other assets, certain of its intellectual property, and has agreed to execute and deliver this Assignment.

B. Assignor is the owner of certain intellectual property (the “**Intellectual Property**”), as more fully identified on Schedule A attached hereto, and

C. Assignor has elected to transfer all of its right, title, and interest in and to the Intellectual Property to Assignee.

AGREEMENT:

NOW, THEREFORE, in consideration of the terms and conditions set forth in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, Assignor hereby sells, assigns, and transfers unto Assignee its entire right, title, and interest in and to the Intellectual Property, together with (i) the goodwill of the business symbolized by any Intellectual Property; (ii) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable to such Assignor with respect to such Intellectual Property; and (iii) and all rights to and claims for damages, restitution, and injunctive and other legal or equitable relief for past, present, or future infringement, misappropriation, or other violation of the Intellectual Property, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, and other legal representatives.

Assignor agrees that it shall execute and/or deliver any additional instrument, and shall take any additional steps, reasonably requested by Assignee in order to effect, evidence, perfect, or enforce Assignee’s rights in and to the Intellectual Property.

The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Intellectual Property. The representations, warranties, covenants, agreements, and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

This Assignment is made and shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania exclusive of any conflicts of law principle that would apply the law of another jurisdiction.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
