## ASSIGNMENT OF TRADEMARKS

A. **Access Holdco Management, LLC**, a limited liability company duly formed and existing under the laws of the State of Delaware, having a place of business located at 3 Ravinia Drive, Suite 400, Atlanta, Georgia 30346 (the “Assignor” or “Company”), is the owner of and has adopted, used, and is using certain trademarks and service marks, including those set forth on Schedule I attached hereto and incorporated by reference herein, which are registered in the United States Patent and Trademark Office (collectively, the “Assigned Marks”);

B. Upon obtaining the unanimous written consent of the Company’s board of managers and sole member, the Company and **ACPAHM (Assignment for the Benefit of Creditors), LLC** (the “Assignee”) executed a certain General Assignment dated August 23, 2018 in which the Company agreed to transfer all of its right, title, and interest to all of its assets to the Assignee in accordance with the laws of the State of Delaware, and in so doing designated the Assignee with the duty of administering the Company’s assignment estate for the benefit of the Company’s creditors (the “General Assignment”); and

C. Assignor desires to transfer its right, title, and interest to the Assigned Marks to Assignee as of August 23, 2018.

NOW, THEREFORE, pursuant to the General Assignment, and in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor does hereby irrevocably convey, assign, transfer, and deliver to Assignee, and assignee does hereby acquire, assume, and accept from Assignor, all of Assignor’s right, title, and interest in and to: (i) the Assigned Marks, including (without limitation) the registrations and any applications for registration thereof and all issuances, renewals, and/or extensions thereof, (ii) all other rights (including common law rights) in, to, and under the Assigned Marks, together with the goodwill of the business connected with the use thereof and symbolized thereby, (iii) all administrative rights relating thereto, (iv) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and/or otherwise throughout the world, (v) any and all claims and causes of action with respect to any of the foregoing or relating to the Assigned Marks, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and/or future infringement, misappropriation, dilution, or other violation thereof, with the right, but not the obligation, to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages, and (vi) any and all proceeds, including (without limitation) license fees, royalties, profits, income, payments, claims, damages, proceeds of suit, and/or remuneration of any kind now or hereafter due and/or payable with respect to any and all of the foregoing, the same to be held and enjoyed by Assignee, its successors, and assigns, or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.

Assignor hereby authorizes and requests that the Commissioner for Trademarks in the United States Patent and Trademark Office record and register this Assignment, as to the Assigned Marks.

Assignor further agrees to execute all documents, instruments, and papers to perform all acts as Assignee may reasonably request to perfect in Assignee the foregoing rights, title, and interests.

This Assignment of Trademarks may be executed simultaneously in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


