- 1. Assignor hereby assigns, grants, and transfers to Assignee all of Assignor's rights benefits, privileges, causes of action, defenses, and remedies relating to the Trademarks. The "Trademarks" consist of the trademark and service mark applications and/or registrations referenced on Exhibit A to this Agreement; any trademark or service mark rights, including common law rights, associated therewith throughout the world; and all good will associated with such trademarks and service marks.
- 2. Assignor agrees that upon request of Assignee, at any time and from time to time, Assignor will execute, acknowledge, and deliver to Assignee such additional documents as Assignee may deem necessary to evidence and effectuate Assignee's rights under this Agreement, and grants to Assignee the right, as attorney-in-fact, to execute, acknowledge, deliver, and record in the U.S. Patent & Trademark Office, and elsewhere, any and all such documents.
