## ASSIGNMENT AGREEMENT

Dated as of March 22, 2017

This Agreement is by and between Pure Athletics, Inc., a Delaware corporation doing business as True Linkswear (hereinafter referred to as "Assignor"), and RMG Worldwide LLC, a Nevada limited liability company (hereinafter referred to as "Assignee").

WHEREAS Assignor borrowed money from Assignee and other third parties;

WHEREAS Assignor's debts were reflected in certain promissory notes, all of which were owned or acquired by Assignee;

WHEREAS Assignor's debts to Assignee were secured by Assignor's assets, which included the Trademarks (as defined below in Section 1);

WHEREAS Assignor defaulted on the promissory notes, giving Assignee the right to foreclose on Assignor's assets securing Assignor's debt to Assignee;

WHEREAS in full payment and satisfaction of the debt, Assignor transferred to Assignee all of Assignor's right, title, and interest in its assets securing the debt, including the Trademarks; and

WHEREAS Assignor and Assignee wish to confirm their intention for Assignee to hold all of Assignor's rights in the Trademarks as of March 22, 2017,

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby assigns, grants, and transfers to Assignee all of Assignor's rights benefits, privileges, causes of action, defenses, and remedies relating to the Trademarks. The "Trademarks" consist of the trademark and service mark applications and/or registrations referenced on Exhibit A to this Agreement; any trademark or service mark rights, including common law rights, associated therewith throughout the world; and all good will associated with such trademarks and service marks.

2. Assignor agrees that upon request of Assignee, at any time and from time to time, Assignor will execute, acknowledge, and deliver to Assignee such additional documents as Assignee may deem necessary to evidence and effectuate Assignee's rights under this Agreement, and grants to Assignee the right, as attorney-in-fact, to execute, acknowledge, deliver, and record in the U.S. Patent & Trademark Office, and elsewhere, any and all such documents.
