TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS, dated as of December 20, 2018 (this "**Termination and Release**"), by Citicorp North America, Inc. ("**CNAI**"), as Senior Collateral Agent (as defined below) and Citicorp USA, Inc., in favor of Rite Aid Corporation (the "**Borrower**"), Name Rite, L.L.C., and Harco, Inc. (f/k/a Harco Drug, Inc.) (together with the Borrower, each a "**Grantor**" and collectively, the "**Grantors**"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Senior Credit Agreement or the Senior Subsidiary Security Agreement, as applicable, referred to below.

Reference is made to (a) the Credit Agreement dated as of June 17, 2001, as amended and restated as of January 13, 2015 (as further amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "**Senior Credit Agreement**"), among the Borrower, the lenders from time to time party thereto and CNAI, as administrative agent and collateral agent (in such capacity, the "**Senior Collateral Agent**"), and (b) the Senior Subsidiary Security Agreement dated as of June 27, 2001, as amended and restated as of June 5, 2009 (as further amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "**Senior Subsidiary Security Agreement**"), among the Borrower, the Subsidiary Guarantors from time to time party thereto and the Senior Collateral Agent.

WHEREAS, pursuant to the Senior Subsidiary Security Agreement, the Grantors granted to the Senior Collateral Agent, for the benefit of the Senior Secured Parties, a security interest in all right, title or interest of the Grantors in certain intellectual property, including, among other things, the trademarks and trademark applications of the Grantors set forth on Schedule I hereto (collectively, the "**Trademarks**"), which security interests were recorded with the United States Patent & Trademark Office on (a) August 9, 2001 at Reel/Frame 2341/0607, (b) August 9, 2001 at Reel/Frame 2340/0001, (c) August 9, 2001 at Reel/Frame 2340/0749, (d) June 18, 2003 at Reel/Frame 2751/0304, (e) September 8, 2000 at Reel/Frame 2126/0654, (f) July 26, 2000 at Reel/Frame 2122/0001 and (g) November 3, 2000 at Reel/Frame 2176/0686.

WHEREAS, pursuant to the First Lien Payoff Letter dated as of December 20, the Senior Collateral Agent agreed to release all right, title and interest granted to it, for the benefit of the Senior Secured Parties, under the Senior Subsidiary Security Agreement in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Senior Collateral Agent hereby (a) terminates, cancels and releases any and all security interests it has in and against the Trademarks and (b) reassigns all right, title and interest it may have in, to or under the Trademarks, together with the goodwill associated therewith, including without limitation any renewals of any of the foregoing, and any proceeds of the foregoing, and any claims

against third parties for past, present or future infringement or dilution of the Trademarks, to the applicable Grantor.

At the Borrower's sole cost and expense, the Senior Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.

THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE SENIOR COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
