SUPPLEMENTAL GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

This SUPPLEMENTAL GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Grant") effective as of October 29, 2018 is made by Enodis Corporation, a Delaware corporation; Manitowoc Foodservice Companies, LLC, a Wisconsin limited liability company; The Delfield Company LLC, a Delaware limited liability company; Cleveland Range, LLC, a Delaware limited liability company; Frymaster L.L.C., a Louisiana limited liability company; and Garland Commercial Industries LLC, a Delaware limited liability company (each, a "Grantor", and collectively, the "Grantors"), in favor of JPMorgan Chase Bank, N.A., with offices at 10 South Dearborn Street, Floor 07, Chicago, Illinois 60603-2003, as Collateral Agent (the "Grantee") for the Lenders party to the Credit Agreement, dated as of March 3, 2016, as amended on October 23, 2018 (as further amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among WELBILT, INC., as the Borrower, ENODIS HOLDINGS LIMITED, as a UK Borrower, the other Subsidiary Borrowers from time to time party thereto, the Lenders and JPMORGAN CHASE BANK, N.A., as Administrative Agent. Unless otherwise defined herein or the context otherwise requires, terms used in this Grant, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement and the Security Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein; and

WHEREAS THIS GRANT is made to secure the satisfactory performance and payment of all the Obligations of the Grantors under the Amended and Restated Security Agreement among the Grantors, the other grantors from time to time party thereto and the Grantee, dated as of October 23, 2018 (as further amended, modified, restated, amended and restated and/or supplemented from time to time, the "Security Agreement").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, each Grantor hereby pledges and grants to the Grantee for the benefit of the Secured Creditors, a continuing security interest in (i) all of the right, title and interest of such Grantor in, to and under all of the United States trademarks, United States trademark registrations and trademark applications set forth on Schedule A attached hereto (the "Marks"), (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

Upon the occurrence of the Termination Date (as defined in the Security Agreement), the Grantee shall execute, acknowledge, and deliver to the Grantors an instrument in writing releasing the security interest in the Marks acquired under this Grant.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are set forth in the Security Agreement, all terms and provisions of which

are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
