TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "**Termination and Release**") is granted as of December 31, 2018 by SILICON VALLEY BANK (the "**Bank**"), in favor of SENTINEL LABS, INC., a Delaware corporation (the "**Grantor**").

- 2. terminates the Grant and releases, terminates and discharges all liens and security interests in Grantor's right, title and interest in, to and under the Patents, and all goodwill associated therewith, including those Patents identified in **Schedule B** hereto; and
- 3. authorizes and requests that this Termination and Release be recorded at the USPTO.
