**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT ("Termination and Release") dated as of January 11, 2019, is made by Deerfield Private Design Fund II, L.P. and Deerfield Private Design International II, L.P. (collectively, the "Secured Party") to Sermo, Inc. ("Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Intellectual Property Security Agreement (defined below) or the Facility Agreement (defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Facility Agreement dated as of March 8, 2013, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Facility Agreement"), by and among the Grantor and Secured Party, the Grantor executed that certain Intellectual Property Security Agreement, dated as of March 8, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement"), which was recorded in the United States Patent and Trademark Office at Reel 5081 Frame 0759 (with respect to the Trademarks) and at Reel 030922 Frame 0915 (with respect to the Patents), and recorded in the United States Copyright Office at Volume 9903 Document 963 (with respect to the Copyrights), pursuant to which the Grantor granted a security interest to Secured Party, in the IP Collateral, including certain patents and/or patent applications, trademarks and/or trademark applications and copyright registrations listed on Schedule A attached hereto and made a part hereof.

WHEREAS, Secured Party now desires to terminate and release its security interest in the IP Collateral and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates, discharges and releases its security interest in all of Grantor's right, title and interest in and to the IP Collateral, including those Patents, Trademarks and Copyrights set forth on Schedule A.

2. If and to the extent that Secured Party has acquired any right, title or interest in or to any of the IP Collateral, Secured Party hereby reassigns, grants and conveys to the Grantor, without any representation or warranty by Secured Party, any and all of its right, title, and interest in and to the IP Collateral (including without limitation those Patents, Trademarks and Copyrights set forth on Schedule A), along with any goodwill in the IP Collateral that Secured Party may have acquired.

3. The Secured Party agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purpose of this Termination and Release.

4. This Termination and Release shall be governed by and construed in accordance with the laws of the State of New York, without giving effect to its choice of law provisions.




