RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of December 24, 2018, is executed by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (the “Administrative Agent”), in favor of LT FOODS AMERICAS, INC., formerly known as KUSHA, INC., a California corporation, LT FOODS USA, LLC, a Texas limited liability company, LT OVERSEAS NORTH AMERICA, INC., a California corporation, UNIVERSAL TRADERS, INC., a California corporation, and ECOLIFE, LLC, a California limited liability company (each a “Grantor”, and collectively, the “Grantors”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

RECITALS

A. WHEREAS, the Grantors have, pursuant to that certain Trademark Security Agreement dated September 29, 2016, recorded in the United States Patent and Trademark Office (the “USPTO”) on October 14, 2016 at Reel 5901, Frame 0114 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Trademark Security Agreement”) granted to Administrative Agent, on behalf of the Secured Parties, a Security Interest in and to all of the Grantors’ right, title and interest, including goodwill, in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Administrative Agent wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

C. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby terminates and releases, without recourse, representation or warranty, its Security Interest in and to the Released Collateral and terminates the Trademark Security Agreement. Administrative Agent acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantors. The Administrative Agent authorizes the Grantors to record this Release with the USPTO and other applicable registry at the sole expense of the Grantors and agrees to provide the Grantors with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.


