**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of January 3, 2019 is made by HPS Investment Partners, LLC, in its capacity as collateral agent (referred to herein as the “Agent”), in favor of Worldwide Media Services Group, Inc. (f/k/a American Media, Inc., a Delaware corporation (“AMI”)), AMI Parent Holdings LLC, a Delaware limited liability company, AMI Digital, Inc., a Delaware corporation, In Store Services Inc., a Delaware corporation, AMI Celebrity Publications, LLC, a Delaware limited liability company, Weider Publications, LLC, a Delaware limited liability company, Platinum Advisory Services LLC a Delaware limited liability company, and American Media, LLC, a Delaware limited liability company (“AML”) (collectively the “Companies”), pursuant to that certain Security Agreement, dated as of August 24, 2016 (and as the same may be further amended or modified from time to time, the “Security Agreement”), among the Companies, the Agent and other parties thereto.

W I T N E S S E T H:

WHEREAS, in connection with the Security Agreement, the Companies executed and delivered those certain Notices of Grants of Security Interests in Trademarks, dated as of August 24, 2016, April 25, 2017 and June 30, 2017, in favor of the Agent (collectively, the “Trademark Security Agreements”);

WHEREAS, in connection with an internal reorganization, AMI assigned its interest in the Trademark Security Agreements to AML, pursuant to that certain Assignment of Notice of Grant in Security Interests, by and between AMI and AML, dated as of October 10, 2018;

WHEREAS, pursuant to the Trademark Security Agreements, the Companies granted to the Agent, for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of the Companies in, to and under the Trademarks, together with the goodwill of the business symbolized by the Trademarks, including the Trademark registrations and applications identified on Schedule A hereto, together with the goodwill of the business symbolized thereby (the “Released Trademarks”);

WHEREAS, the Agent recorded its security interest in the Released Trademarks with the United States Patent and Trademark Office (the “USPTO”) on (i) August 29, 2016 at Reel/Frame No. 5866/0188; (ii) May 4, 2017 at (Reel/Frame No. not yet available); (iii) July 17, 2017 (Reel/Frame No. not yet available) and (iii) November 9, 2018 at Reel/Frame No. 6478/0912; and

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Companies, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreements, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Security Agreements).

SECTION 2. Release of Security Interest. The Agent does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, all of the Companies' right, title and interest in, to and under the Released Trademarks.

SECTION 3. Termination. The Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreements.

SECTION 4. Further Assurances. The Agent hereby authorizes the Companies or the Companies' authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Agent in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to the Companies any and all further documents and instruments, and do any and all further acts which the Companies (or their agents or designees) reasonably request (at the Companies' sole cost and expense) in order to confirm this Release and the Companies' right, title and interest in, to and under the Released Trademarks.

SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

SECTION 6. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.


