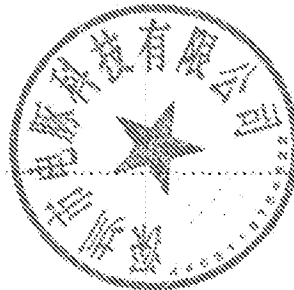
## Trademark assignment
