Assignor does hereby transfer, assign, grant and convey to Assignee all of its right, title and interest in and to that certain (i) Trademark Security Agreement dated February 27, 2015 (recorded at the United States Patent and Trademark Office (the "USPTO") on April 6, 2015 at Reel 5493 and Frame 0346), (ii) Patent Security Agreement dated February 27, 2015 (recorded at the USPTO on April 6, 2015 at Reel 035375 and Frame 0867), (iii) Trademark Security Agreement dated June 7, 2017 (recorded at the USPTO on June 2, 2017 at Reel 6078 and Frame 0400), and (iv) Patent Security Agreement dated June 2, 2017 (recorded at the USPTO on June 6, 2017 at Reel 042615 and Frame 0531), and any rider, addendum, exhibit, schedule and attachment thereto (collectively, the "Security Instruments"), together with all attendant liens, rights, title, assignments, interests (including security interests) thereto, and the recordations mentioned above. Furthermore, Assignor does hereby grant and delegate to Assignee any and all of the duties and obligations of Assignor under each of the Security Instruments from and after the date hereof.
