## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "ASSIGNMENT") dated as of November 12, 2018, is made by and between ABT Molecular Imaging, Inc., a Delaware corporation having its principal place of business at 3024 Topside Business Park Dr., Louisville, TN 37777 U.S.A. ("ASSIGNOR"), and Best ABT Inc., Inc., a Virginia corporation having a principal place of business at 7643 Fullerton Road, Springfield, VA 22153 U.S.A. ("ASSIGNEE"). ASSIGNOR and ASSIGNEE may each be referred to herein individually as a "PARTY" and collectively as the "PARTIES."

### WITNESSETH:

WHEREAS, ASSIGNOR and ASSIGNEE, entered into that certain Asset Purchase Agreement, dated as of October 31, 2018 (the "ASSET PURCHASE AGREEMENT"); and

WHEREAS, pursuant to the ASSET PURCHASE AGREEMENT, ASSIGNEE shall purchase and accept and ASSIGNOR shall transfer and assign to ASSIGNEE all of ASSIGNOR'S right, title and interest in, to and under certain of ASSIGNOR'S trademarks, and any registrations thereof or applications therefor, including those listed in Schedule A hereto and including all goodwill associated therewith (the "TRADEMARKS").

NOW, THEREFORE, in consideration of the premises and covenants set forth herein and in the ASSET PURCHASE AGREEMENT and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Section 1.1 Assignment. ASSIGNOR hereby sells, transfers, conveys, assigns and delivers to ASSIGNEE, and ASSIGNEE hereby purchases and accepts from ASSIGNOR, all of ASSIGNOR'S right, title and interest in, to, and under the TRADEMARKS, including, but not limited to, the goodwill associated therewith and the exclusive rights to (a) bring actions, defend against or otherwise recover for infringements, and the right to the royalties, profits or damages due or accrued, arising out of or in connection with any and all past, present or future infringements of the TRADEMARKS, (b) apply for, make filings with respect to and maintain all registrations, renewals and extensions thereof, and (c) all other rights of any kind whatsoever of ASSIGNOR accruing thereunder.

Section 1.2 Acknowledgement. ASSIGNOR hereby acknowledges and agrees that from and after the date hereof, as between the PARTIES, ASSIGNEE shall be the exclusive owner of the TRADEMARKS.

Section 1.3 Cooperation. This ASSIGNMENT has been executed and delivered by the ASSIGNOR for the purpose of recording the assignment herein with the appropriate government entity. At ASSIGNEE'S sole cost and expense, ASSIGNOR shall execute and deliver such other documents and take all other actions which



This ASSIGNMENT and the ASSET PURCHASE AGREEMENT between the PARTIES hereto, and dated as of the date hereof, constitute the entire understanding and agreement of the PARTIES hereto with respect to the subject matter hereof and supersede all prior and contemporaneous agreements or understandings, inducements or conditions, express or implied, written or oral, between and among the PARTIES with respect hereto. Nothing contained in this ASSIGNMENT supersedes, alters or modifies any of the obligations, agreements, covenants or warranties of ASSIGNOR or ASSIGNEE under the ASSET PURCHASE AGREEMENT. In the event of any conflict between the terms of this ASSIGNMENT and the terms of the ASSET PURCHASE AGREEMENT, the terms of the ASSET PURCHASE AGREEMENT, as applicable, shall control. This ASSIGNMENT shall not be interpreted to broaden the scope of ASSIGNEE'S rights with respect to the TRADEMARKS beyond those rights provided in the ASSET PURCHASE AGREEMENT. This ASSIGNMENT may not be supplemented, altered, or modified in any manner except by a writing signed by the PARTIES hereto. The failure of any PARTY to enforce any terms or provisions of this ASSIGNMENT shall not waive any of its rights under such terms or provisions. This ASSIGNMENT shall bind and inure to the benefit of the respective PARTIES and their assigns, transferees and successors.

Section 1.5 Governing Law; Jurisdiction and Venue. This ASSIGNMENT shall be governed by, and construed in accordance with, the laws of the Commonwealth of Virginia, without regard to any conflict of laws provisions thereof that would result in the application of the laws of another jurisdiction. Both ASSIGNEE and ASSIGNOR hereby consent to and submit to the exclusive jurisdiction and venue of the federal and state courts located in the Fairfax, Virginia for enforcement or interpretation of this ASSIGNMENT, and for any disputes under or arising out of this ASSIGNMENT.

Section 1.6 Counterparts. This ASSIGNMENT may be executed in counterparts, each of which will be an original as regards any party whose signature appears thereon and both of which together will constitute one and the same instrument.


