WHEREAS, pursuant to the terms of a Security Agreement dated December 29, 2008 by and between Grantor and Secured Party, as amended (as may be further amended and in effect from time to time, the "Security Agreement"), Grantor has granted to Secured Party a security interest, lien and collateral assignment in and to all assets of Grantor, including all right, title and interest of Grantor in, to and under all now owned and hereafter acquired (i) patents, patent applications and patent licenses, and all products and proceeds thereof and (ii) (a) all trademarks, service marks, trade names, corporate names, Debtor names, business names, fictitious names, trade dress, service marks, trade styles, logos and other designs or sources of business identifiers or other indicia of trade origin, (b) all trademark and service mark registrations and applications for trademark or service mark registrations and (c) any and all extensions and renewals of or with respect to any of the foregoing, to secure the payment of all Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and to further evidence the security interest, lien and collateral assignment granted to Secured Party by Grantor under the Security Agreement, Grantor does hereby grant to Secured Party a continuing security interest, lien and collateral assignment in all of Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Patent and Trademark Collateral"), whether presently existing or hereafter created or acquired:

(1) each patent and patent application, including, without limitation, each patent and patent application referred to in Schedule 1 annexed hereto, together with any reissues, continuations, divisions, modifications, substitutions, or extensions thereof;

(2) all products and proceeds of the foregoing item (1), including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any patent, including, without limitation, any patent referred to in Schedule 1 annexed hereto and any patent issued pursuant to a patent application referred to in Schedule 1 annexed hereto;

(3) all trademarks, service marks, trade names, corporate names, Debtor names, business names, fictitious names, trade dress, service marks, trade styles, logos and other designs or sources of business identifiers or other indicia of trade origin referred to in Schedule 2 annexed hereto; and

(4) all trademark and service mark registrations and applications for trademark or service mark registrations referred to in Schedule 2 annexed hereto; and

(5) all products and proceeds of the foregoing items (3) and (4), including, without limitation, any claim by Grantor against third parties for past, present or future infringement of

any trademark, including, without limitation, any trademark referred to in Schedule 2 annexed hereto and any trademark issued pursuant to a trademark application referred to in Schedule 2 annexed hereto


This security interest is granted in conjunction with the security interests granted to Secured Party pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Secured Party with respect to the security interest in the Patent and Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
