The undersigned, for the purpose of converting Orbit Irrigation Products, Inc., a Utah corporation (the "*Converting Entity*"), into Orbit Irrigation Products, LLC, a Utah limited liability company ("*the Converted Entity*"), pursuant to the Utah Revised Uniform Limited Liability Company Act (the "*Act*") and the Utah Revised Business Corporation Act, hereby certifies as follows:

1. **Incorporation and Jurisdiction of the Converting Entity.** The Converting Entity's Articles of Incorporation were filed under the laws and jurisdiction of the State of Utah on February 2, 1996, and its entity number is 1295793-0142. The Converting Entity has not changed its jurisdiction at any time prior to the filing of this Statement of Conversion.

2. **Name and Entity Type of the Converting Entity.** Immediately prior to the filing of this Statement of Conversion, (i) the name of the Converting Entity was Orbit Irrigation Products, Inc. and (ii) the Converting Entity was a Utah corporation.

3. **Name and Entity Type of the Converted Entity.** Upon the filing of this Statement of Conversion and the Certificate of Organization attached hereto as Exhibit A, (i) the name of the Converted Entity will be Orbit Irrigation Products, LLC and (ii) the Converted Entity will be a Utah limited liability company.

4. **Effective Time.** The effective date and time of the conversion shall be upon the filing of this Statement of Conversion.

5. **Conversion of Issued Shares.** Effective as of the filing hereof, the shares of capital stock of the Converting Entity, all of which are owned by its sole shareholder, are hereby converted into a one hundred percent membership interest in the Converted Entity.


6. **Shareholder Approval.** The conversion effected hereby, pursuant to a plan of conversion, has been duly approved by the sole shareholder of the Converting Entity in accordance with Sections 48-3a-1041 through 48-3a-1046 of the Act and the applicable provisions.
