The Seller hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to record the title of Buyer, its successors, legal representatives and assigns, as owner of all right, title and interest in and to the Marks, together with all goodwill of the business associated with and symbolized by the Marks, and to issue the Certificate of Registration resulting from any such application for registration of the Marks or renewal of the registration of the Marks to Buyer, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

The Seller agrees that it will execute and deliver, or cause to be executed and delivered, to Buyer or Buyer's legal representatives, any other or additional assignments, powers and other appropriate documentation, and provide Buyer with all reasonable additional assistance necessary to effectuate, validate and record the Assignment of the Marks to Buyer with the United States Patent and Trademark Office, within a reasonable time of execution hereof.
