**TERMINATION OF SECURITY INTEREST AND RELEASE OF COLLATERAL**

THIS TERMINATION OF SECURITY INTEREST AND RELEASE OF COLLATERAL (“**Release**”) is made effective as of February 1, 2019 (the “**Effective Date**”) by BMO Harris Bank N.A., as administrative agent for certain lenders (the “**Agent**”).

**WHEREAS**, Highland Ridge RV, Inc. (“**Highland Ridge**”), Airstream, Inc. (“**Airstream**”), Heartland Recreational Vehicles, LLC (“**Heartland**”), Keystone RV Company (“**Keystone**”), K.Z., Inc. (“**K.Z.**”), Jayco, Inc. (“**Jayco**”), KZRV, L.P. (“**KZRV**”), Thor Tech, Inc. (“**Thor Tech**” and together with Highland Ridge, Airstream, Heartland, Keystone, K.Z., Jayco, and KZRV, the “**Grantors**”) previously granted Agent, on behalf of the lenders, a security interest in and continuing lien on all of Grantors' rights, title and interest in, to and under the patents, trademarks, and copyrights listed on Schedule A (attached hereto) (collectively, the “**Intellectual Property Collateral**”), pursuant to the agreements listed on Schedule B hereto (as amended, supplemented, amended and restated or otherwise modified from time to time, the “**Security Agreements**”);

**WHEREAS**, the Grantors and its affiliates have paid all of their outstanding indebtedness to the Agent secured by, among other assets, the Intellectual Property Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) releases, discharges and disclaims any and all liens, security interests, pledges and/or assignments created in the Agent's favor with respect to the Intellectual Property Collateral, and (ii) grants, reassigns and conveys, without any covenant or warranty, express or implied, to Grantors any and all rights, title and interest of the Agent in the respective Intellectual Property Collateral owned by each Grantor.

The Agent represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Intellectual Property Collateral.

The Agent hereby authorizes Grantors, Grantors' authorized representatives, and new lenders and agents thereof to (i) file this Release with the United States Patent and Trademark Office, (ii) file this Release with the U.S. Copyright Office, and/or (iii) otherwise file this Release in any additional applicable governmental office or agency.

The Agent shall take all further actions, and provide to Grantors, and each of their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.
