TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT, dated as of February 8, 2019 (this “**Agreement**”), by and among THE DUN & BRADSTREET CORPORATION, a Delaware corporation, AVENTION, INC., a Delaware corporation, DUN & BRADSTREET EMERGING BUSINESSES CORP., a Delaware corporation, DUN & BRADSTREET INTERNATIONAL, LTD., a Delaware corporation, DUN & BRADSTREET NETPROSPEX, INC., a Delaware corporation, DUN & BRADSTREET, INC., a Delaware corporation and HOOVER’S, INC., a Delaware corporation (each, a “**Grantor**”) and WILMINGTON TRUST, NATIONAL ASSOCIATION, as collateral agent for the Notes (as defined in the Indenture) (in such capacity, the “**Collateral Agent**”).

Reference is made to (a) the Indenture dated as of February 8, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Indenture**”), by and between Star Merger Sub, Inc., a Delaware corporation (“**Merger Sub**” and, prior to the Acquisition (as defined therein), the Issuer), which upon the effectiveness of the Acquisition will be merged with and into The Dun & Bradstreet Corporation, a Delaware corporation (the “**Target**” and, after giving effect to the Acquisition, the “**Issuer**”), Wilmington Trust, National Association, as the trustee for the Notes and the Collateral Agent and (b) the Security Agreement dated as of February 8, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) by and among Merger Sub, the Issuer, the Subsidiary Guarantors (as defined therein) from time to time party thereto and the Collateral Agent. The Holders (as defined in the Indenture) have agreed to purchase the Notes from the Issuer subject to the terms and conditions set forth in the Indenture. Each Grantor is willing to execute and deliver this Agreement in order to induce the Holders to purchase the Notes. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the Secured Obligations, each Grantor, pursuant to the Security Agreement, did and hereby does grant to the Collateral Agent, its successors and assigns, for the benefit of the Notes Secured Parties (as defined in the Indenture), a security interest (the “**Security Interest**”) in all of such Grantor’s right, title and interest in, to and under the United States Trademarks listed on Schedule I attached hereto (the “**Trademark Collateral**”). This Agreement is not to be construed as an assignment of any Trademark. Notwithstanding anything herein to the contrary, the Trademark Collateral shall not include, and in no event shall the Security Interest attach to, any intent-to-use trademark applications filed in the United States Patent and Trademark Office, pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. Section 1051, prior to the accepted filing of a “Statement of Use” and issuance of a “Certificate of Registration” pursuant to Section 1(d) of the Lanham Act or an accepted filing of an “Amendment to Allege Use” whereby such intent-to-use trademark application is converted to a “use in commerce” application pursuant to Section 1(c) of the Lanham Act.

SECTION 3. Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 4. Termination. Subject to Section 7.12 of the Security Agreement, upon the occurrence of the Termination Date, the security interest granted herein shall terminate and the Collateral Agent shall execute, acknowledge, and deliver to the Grantors all instruments in writing in recordable

form to evidence and release the collateral pledge, grant, lien and security interest in the Trademark Collateral under this Agreement.

SECTION 5. Authorization. Each Grantor hereby authorizes and requests that the Commissioner of Patents and Trademarks record this Agreement.

SECTION 6. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Agreement by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this Agreement.

SECTION 7. Governing Law. This Agreement shall be construed in accordance with and governed by the laws of the State of New York.

SECTION 8. Conflicts. Notwithstanding anything contrary contained herein, in the event of any conflict or inconsistency between this Agreement and the Indenture, the terms of the Indenture shall govern and control.

SECTION 9. Concerning the Collateral Agent. Wilmington Trust, National Association is entering this Agreement solely in its capacity as "Notes Collateral Agent" under the Indenture, and in acting hereunder, shall be entitled to all of the rights, privileges, immunities and indemnities granted to the "Notes Collateral Agent" in the Indenture as if such rights, privileges, immunities and indemnities were set forth herein.
