**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of February 13, 2019, by **JEFFERIES FINANCE LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, “Agent”) in favor of **CLAIM JUMPER ACQUISITION COMPANY LLC** (“Grantor”), a Nevada limited liability company with an address at 1510 West Loop South, Houston, Texas 77027 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated October 4, 2016 (the “Trademark Security Agreement”) with Agent, notice of which was recorded on October 5, 2016 at the United States Patent and Trademark Office at Reel 5891, Frame 0840.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in and to all of its Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (without recourse and without any representation or warranty) any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys (without recourse and without any representation or warranty) to Grantor any interest in such intellectual property, including the Security Interest.
