TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made this 8th day of February, 2019 (the “Release Date”) by Wells Fargo Capital Finance, LLC (f/k/a Wells Fargo Foothill, Inc.), a Delaware limited liability company, as agent (the “Agent”), for the benefit of Take-Two Interactive Software, Inc., a Delaware corporation (the “Grantor”).

WHEREAS, the Grantor has entered into that certain Security Agreement, dated as of July 3, 2007 (including all annexes, exhibits, or schedules thereto as from time to time amended, restated, supplemented or otherwise modified) with the Agent (as at any time prior to the date hereof amended, supplemented or otherwise modified, the “Security Agreement”), pursuant to which the Grantor granted to the Agent, for the benefit of the Lender Group and the Bank Party Providers a continuing first priority security interest in all of the right, title and interest of the Grantor in, to and under all of the following, whether then existing or thereafter created or acquired (collectively, the “Trademark Collateral”):

- (i) all of the Grantor’s Trademarks (as defined in the Trademark Security Agreement) and rights in and to Trademark Intellectual Property Licenses (as defined in the Trademark Security Agreement) to which it is a party, including, without limitation, those referred to on Schedule I hereto;
- (ii) all renewals and extensions of the foregoing;
- (iii) all products and proceeds of the foregoing, including any claim by the Grantor against third parties for past, present, or future (x) infringement or dilution of any Trademark or any Trademark licensed under any Trademark Intellectual Property License or (y) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark Intellectual Property License.
- (iv) all goodwill of the business connected with the use of, and symbolized by, each such Trademark and each such Trademark Intellectual Property License;

WHEREAS, the Agent has filed with the United States Patent and Trademark Office (the “USPTO”) Confirmations of Security Interest Grants (Trademarks), (collectively, the “Trademark Security Agreement”) recorded by the USPTO at the following Reel/Frame numbers:

WHEREAS, the Secured Obligations and the Security Agreement and the Trademark Security Agreement and all Commitments have been terminated, and the Grantor has requested that the Agent release its security interest in the Trademark Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Agent hereby irrevocably and forever terminates, releases and discharges the Security Agreement and the Trademark Security Agreement, any and all of its security interest in, and all of its right, title and interest in, to and under, the Trademark Collateral granted by the Grantor under the Security Agreement and the Trademark Security Agreement.

2. Recordation of Release. The Agent understands and agrees that this Release may be recorded by or for the Grantor with the USPTO.

3. Further Actions. The Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release; provided, that the cost and expense of such documents and actions shall be borne solely by the Grantor.


4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement.
