**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is dated as of February 22, 2019 by **SILICON VALLEY BANK** (“*Bank*”), in favor of **ROKU, INC.**, a Delaware corporation (“*Grantor*”).

**WHEREAS**, pursuant to a Loan and Security Agreement dated as of January 20, 2009 by and between Grantor and Bank, Grantor executed and delivered an Intellectual Property Security Agreement, dated as of January 20, 2009 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*2009 Agreement*”), granting and pledging to the Bank a security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with (i) the Patent division of the United States Patent and Trademark Office (“*USPTO*”) on February 9, 2009 at Reel 022266, Frame 0112 and on July 20, 2010 at Reel 024711, Frame 0260 and (ii) the Trademark division of the USPTO on February 12, 2009 at Reel 3951, Frame 0131 and on July 20, 2010 at Reel 4245, Frame 0237;

**WHEREAS**, pursuant to a Loan and Security Agreement dated as of July 26, 2010 by and between Grantor and Bank, Grantor executed and delivered (a) an Intellectual Property Security Agreement, dated as of July 26, 2010 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*2010 Agreement*”), granting and pledging to the Bank a security interest in all of Grantor’s right, title and interest in, to certain intellectual property, (b) an Intellectual Property Security Agreement, dated as of April 27, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*April 2012 Agreement*”), granting and pledging to the Bank a security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with the United States Copyright Office (“*USCO*”) on May 9, 2012 at Volume 3605 Doc No. 937, (c) an Addendum to Intellectual Property Security Agreement, dated as of May 31, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*May 2012 Addendum Agreement*”), granting and pledging to the Bank a security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with (i) the Patent division of the USPTO on June 4, 2012 at Reel 028316, Frame 0958; (ii) the Trademark division of the USPTO on June 4, 2012 at Reel 4794, Frame 0322 and (iii) the USCO on June 11, 2012 at Volume 3616 Doc No. 819;

**WHEREAS**, pursuant to an Amended and Restated Loan and Security Agreement dated as of November 18, 2014 by and between Grantor and Bank, Grantor executed and delivered (a) an Addendum to Intellectual Property Security Agreement, dated as of May 14, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*2015 Agreement*”), granting and pledging to the Bank a security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with (i) the Patent division of the USPTO on June 1, 2015 at Reel 035753, Frame 0739 and (ii) the Trademark division of the USPTO on June 1, 2015 at Reel 5526, Frame 0959 and (b) an Amended and Restated Intellectual Property Security Agreement, dated as of June 9, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*A&R IP Agreement*”, together with the 2009 Agreement, the 2010 Agreement, the April 2012 Agreement, the Addendum 2012 Agreement,

and the 2015 Agreement, each individually and collectively, jointly and severally, the “*Intellectual Property Security Agreement*”), granting and pledging to the Bank a security interest in all of Grantor’s right, title and interest in, to and under certain intellectual property, which was recorded with (i) the Patent division of the USPTO on June 12, 2017 at Reel 042768, Frame 0268, (ii) the Trademark division of the USPTO on June 12, 2017 at Reel 6082, Frame 0256, and (iii) the USCO on June 13, 2017 at Volume 9949 Doc No. 778;

**WHEREAS**, Grantor has requested that Bank hereby terminate the Intellectual Property Security Agreement as herein provided; and

**WHEREAS**, Grantor has requested that the Bank provide a document suitable for recording with the USPTO and USCO to evidence the termination of the Intellectual Property Security Agreement as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Intellectual Property Security Agreement and releases, terminates and discharges the liens on and security interests in Grantor’s right, title and interest in, to and under the intellectual property as granted in the Intellectual Property Security Agreement, including those copyrights and copyright applications, patents and patent applications, and trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO and USCO.

THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF CALIFORNIA (INCLUDING, WITHOUT LIMITATION, SECTION 5-1401 OF THE GENERAL OBLIGATIONS LAW) WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES.
